



SPEECH OF SHRI KANUBHAI DESAI FINANCE MINISTER ON BUDGET ESTIMATES

2022-2023 (PART-A)

Honourable Speaker Madam,

I heartily congratulate you for being nominated as the first lady speaker of this august house.

Our country is about to complete 75 years of its independence. Gujarat is marching ahead on the path of development with the motto of "Sauno sath ane Sauno Vikas" on this momentous occasion of "Azadi Ka Amrut Mahotsava". Our Government has resolved to take Gujarat to newer heights of progress with additional motto of "Sauno Vishwas ane Sauno Prayas". I am delighted to have this honour, for the first time, to present budget of the state, as a part of herculean task of building "Atmanirbhar Bharat" by making "Atmanirbhar Gujarat".

Under the able leadership of the beloved son of Gujarat, Honourable Prime Minister Shri Narendrabhai Modi, our country is firmly advancing towards the goal of good governance and economic development. Whole world is applauding us for launching the biggest vaccination drive against the Covid-19 pandemic, with more than 177 crores doses of the indigenous COVID vaccine administered free of cost to protect the people of the country. Under the leadership of Honourable Chief Minister Shri Bhupendrabhai Patel, our government with the help of people, has provided safety net against the pandemic by providing more than 10 crores doses against the estimated eligible population of 5.25 crores which includes all citizens above the age of 15 years.

Under the guidance of Honourable Prime Minister Shri Narendrabhai Modi, Indian economy has withstood serious challenges posed by the pandemic to become the fastest growing economy among the major economies of world. Our country is poised to enter the elite club of 5 trillion-dollar economy. Gujarat has made significant contribution in the progress of India.When respected Shri Narendrabhai took over reins of the state, GSDP was only $\gtrless1$ lakh 25 thousand crores. After two decades of sincere and result-oriented administration as well as the untiring efforts of our successive governments, GSDP of state has crossed the mark of $\gtrless20$ lakh crores. In these 20 years, per capita income has also increased substantially from $\gtrless19,823$ to $\gtrless2,14,809$.

Under the decisive leadership of humble, modest and unassuming Honourable Chief Minister Shri Bhupendrabhai Patel, our government which is committed to public service, has undertaken various public welfare measures. As a result of these efforts, Gujarat has secured first position in the Good Governance Index at the national level. For this achievement, I offer my congratulations to all *Karmayogi (employees)* and the citizens of the state. Our government has made available as many as 280 services at the door-step of people through Digital Seva Setu app. which includes services pertaining to ration card, birth and death certificate, certificate of income, revenue documents etc. Validity period of the income certificate for government schemes has been extended to three years. By allowing self-declaration in the place of affidavit, we have also taken a significant step in the direction of simplifying administrative procedures.

Honourable Prime Minister has given a call for adoption of JAM principle i.e. Jan-Dhan account, Adhaar and Mobile, for extending benefits of government schemes to deserving beneficiaries. In this direction, our government has adopted DBT system, where online applications are received through the Digital Gujarat portal and monetary assistance is promptly deposited directly in the bank account of the beneficiary. Every year, around **₹20 thousand crores** are transferred to the beneficiary account through DBT. Government has operationalized electronic receipt system through cyber treasury in order to promote digital transactions.

The Government has taken a number of steps to increase income of farmers and to make agriculture remunerative. Organic farming is being encouraged so as to reduce expenses and to increase earnings. The Dangs district has become the first district to fully adopt organic farming. Government has taken immediate relief measures for the farmers at the time of natural disasters. At present, an interest subvention scheme is being implemented for short term crop loans for Kharif crop. *I Propose a new scheme to provide interest subvention on the short term crop loan during the Rabi and Summer crop as well.*

There was a demand by the livestock owners and the fishermen for providing them a scheme of interest subvention for loan under the Kisan Credit Card (KCC) as that to the farmers. *In order to increase the productivity of the Animal Husbandary and Fisheries sector, I propose a scheme to provide interest subvention on the short term loans to livestock owners and the fishermen. Under this scheme, it is expected that an estimated 8 to 10 thousand crores of loan will be availed.*

Cow has immense importance in the Indian culture. Since the time of *Dwarikadhish Lord Shri Krishna*, cow protection and cow rearing has assumed huge significance. Our government is working actively for protection and conservation of cows and breeding of local varieties. Non-government and voluntary organizations are also contributing significantly along with the government, in preservation and protection of cows. *Panjarapoles* and *Gaushalas* in the state are taking care of thousands of cows and other animals. To fulfil the resolve of our government towards cows, *I propose "Mukhyamantri Gau Mata Poshan Yojna", for the running and maintenance of Gaushalas and Panjarapoles. A provision of ₹500 crores is proposed in the next year for this scheme. Further, a provision of ₹100 crores is proposed for undertaking activities in urban and rural areas to address issue of stray animals.*

In order to have bright future of the coming generations in the state and with an objective of all-inclusive development of students through excellent and quality education it has been decided to setup "*Schools of Excellence*". It is a World Bank assisted project with an outlay of **₹10 thousand crores**, through which it is planned to provide better infrastructural facilities and quality education to more than 70 lakh students,

Women and children are the bedrock of the society. Today's adolescent girls are the mothers of tomorrow. Health care and nutrition at every stage of life is necessary for a healthy future generation. First thousand days from the conception to the completion of two years of a child are considered as golden period. Therefore, the government has resolved to implement various schemes to strengthen health and nutrition of the adolescent girls, pregnant women and lactating mothers. *I propose Suposhit Mata - Swasth Bal Yojana with an outlay of* ₹4 *thousand crores for the next five years to make available Protein, Fats and Micro nutrients in the diet of pregnant women and lactating mothers for 1000 days. Under the scheme it is proposed to give monthly supply of 1 kg pigionpea (Tuver Dal), 2 kg gram and 1 kg edible oil free of cost.*

Honourable Prime Minister has launched *PM Gati Shakti* program for strengthening infrastructural facilities through National Infrastructure Pipeline scheme with projects worth **₹100 lakh crores.** Our governments have put in untiring efforts to build excellent infrastructure in Gujarat, which include:

- Well-planned road network of 1 lakh 24 thousand kilometres, connecting villages of the state;
- Transmission network of approximately 70 thousand kilometres and distribution network of more than 17 lakh kilometres, providing 24×7 power supply;
- Unique bulk transmission pipeline network of 2700 kilometres, and distribution pipeline network of 31500 kilometres for gas supply;
- A huge canal network of 63 thousand kilometres under *Sardar Sarovar* Project for irrigation, providing big relief from water scarcity;
- Drinking water pipe network having 3 thousand kilometres of bulk pipeline and gigantic network of more than 1 lakh 20 thousand kilometres of distribution pipeline.

The government is committed for greater investment in the infrastructure sector to improve well-being of the people of Gujarat and to boost economy.

Our government, with well drafted *policy on ports*, has developed more than 40 big and small ports, and a number of jetties along the coastline. Gujarat ranks first in the country with 22 percent share of handling import-exports cargo. Thus, Gujarat has truly become the gateway of the country for global trade.

The first *bullion market* of the country is being setup at the GIFT city in Gujarat, which will enable gold and silver trading which was so far conducted in foreign countries only. Banking, leasing, insurance, finance and arbitration services of international class are being offered at the GIFT city. Gujarat is emerging as global hub for financial business.

Gujarat is consistently ranked at the first place in the *LEADS Index* of the Central Government, for the last three consecutive years due to a well-developed road network offering easy and faster movement of goods and passengers. The state has attracted foreign direct investment (FDI) of Rs. one lakh sixty-three thousand crores during the year 2020-21, which is 37% of total FDI received in the country. The people centric government and balanced development has thus made Gujarat – the best destination for investment. Our government has established *Kaushalya-the Skill University* for the youths of the state to acquire employment-oriented skills to take full benefit of the large scale job opportunities being generated in Gujarat.

Keeping in view the importance of start-ups in building of New-India, Honourable Prime Minister Shri Narendrabhai Modi has declared 16th January as the National Start-up Day. Golden era of the Indian Start-Up is set to begin. Gujarat has announced *Student Start-up and Innovation Policy 2.0* to provide financial assistance to the youth of the state to enable them to be a part of this Start-Up revolution.

The government is committed to use of modern technology particularly drones to change the administrative processes and to make service delivery more efficient. *Drone research and development centre* as well as drone training institutions will be established in the coming days in the state to increase the use of drones in the field of agriculture, land measurement, health, infrastructural works, law and order, etc.

Under the leadership of Honourable Chief Minister Shri Bhupendrabhai Patel, our government has announced new *IT Policy* to boost up investment in the information technology sector with the objective of creating new employment opportunities. Under this policy, world class IT infrastructure will be set up for creation and retention of high-skilled manpower. The government has also announced *Bio-Technology Policy* to encourage various activities like bio-plastics, gene-splicing, stem cell therapy etc. These policies of IT and BT will help to generate more than 2 lakh new employment opportunities in the state.

Good financial management is essential for effective and result-oriented administration. As per the criterion laid down by the NITI Ayog, Gujarat ranks first in the country in financial management. Gujarat has never gone for any overdraft in the last two decades in spite of allocating higher budgetary resources for the development of the state year after year. The state is expected to register an **impressive double digit GSDP growth of 13%** despite adverse impact of Covid.

I propose a budgetary outlay of **₹2 lakhs 43 thousand and 965 crores** for the financial year 2022-23 increasing outlay for different sectors despite debilitating adverse impact of covid pandemic; I am sure it will give impetus to growth and bring prosperity and happiness to all sections of society.

Agriculture, Farmers' Welfare and Cooperation

Total provision of ₹7737 Crores for Agriculture, Farmers' Welfare and Cooperation.

Honourable Prime Minister has given a clarion call to the farmers to turn to organic farming along with initiating novel experiments in the agriculture sector, using modern technology for enhancing farmer's income. Be it the matter of *Pradhanmantri Kisan Samman Nidhi* or helping them at the time of natural disasters, our government is working tirelessly day and night for farmers.

Keeping the welfare of the farmers in focus, the scheme to provide subvention of **₹6 thousand** per year to every farmer household under *Pradhanmantri Kisan Samman Nidhi* has been implemented. Under this scheme, approximately 61 lakh farmers in Gujarat have received a total amount of **₹10 thousand crores** in their bank accounts through direct transfer of payment.

A huge subsidy of **₹8 thousand 300 crores** is provided to make agricultural connections available to farmers with subsidiesed power. All the pending applications for the power connection will be cleared before the *Amrut Mahotsav* of independence to provide power connections to farmers.

- A provision of ₹2310 crores for various schemes for crop husbandry.
- A provision of ₹260 crores to provide subvention in purchasing tractors and various farm machineries under mechanization of agriculture.
- Provision of ₹231 crores for various projects related to agriculture and allied sectors under *Rashtriya Krishi Vikas Yojana*.
- A provision of ₹213 crores for maintenance of cows for the farmers who are engaged in organic farming entirely based on cows.
- A provision of **₹142 crores** for constructing small godowns on farms under *Mukhymantri Pak Sangrah Yojana*.
- *Gujarat Prakrutik Krushi Vikas Board* has been formed to provide a boost to organic farming. The board will work towards enhancing agricultural production by integrating farmers with this campaign. A provision of ₹100 crores for this purpose.

- A provision of **₹100 crores** to provide subvention to Agro and Food Processing Units under *Sarvagrahi Krishi Vyavasay Niti*.
- A provision of **₹81 crores** under *Khedut Khatedar Akasmat Bima Yojana*.
- A provision of ₹54 crores to provide one drum and two plastic baskets free of cost to farmers of the state to carry out multipurpose activities.
- A provision of ₹35 crores for increasing agricultural production by sprinkling fertilizers and insecticides with the help of drone and thereby decreasing the cost of agricultural inputs.
- A provision of ₹32 crores to encourage farmers engaged in organic farming in the Dangs district, for entirely chemical free cultivation.
- A provision of ₹20 crores for eracting solar power fancing around farms to prevent the crop being damaged by wild animals.
- A provision of **₹17 crores** for storage of fertilizers in order to provide fertilizer to the farmers in time and in adequate quantity.
- A provision of **₹15 crores** to provide subvention on the purchase of goods carrying vehicles for transportation of agricultural products.
- A provision of **₹10 crores** to promote *"Sanedo"*, an agricultural implement, developed by local manufacturers of the state.

Horticulture

Total provision of ₹369 crores for the schemes under the Directorate of Horticulture.

- A provision of **₹10 crores** to increase the area under cultivation of *Kamalam* (dragon fruit).
- A provision of **₹10 crores** to engage 10,000 farmers of the state in honey production to provide a boost to the *Honey Revolution*.

- A provision of **₹7 crores** under Comprehensive Horticulture Development Program.
- A provision of ₹7 crores to establish 3 centres of excellence for horticulture crops, one each at Ahmedabad, Jamnagar and Kheda districts.

Agricultural Universities

• A provision of ₹757 crores to intensify Agricultural Research and Education Programs under agricultural universities.

Animal Husbandry

- A provision of ₹300 crores for interest relief to Animal keepers on sort term loan.
- A provision of **₹500 crores** to Gaushala, Panjrapole and Trust managed institutions for preservation of cow and infrastructural facilities in *Mukhyamantri Gaumata Poshan Yojana*.
- A provision of **₹50 crores** to look after the stray animals in rural areas.
- A provision of **₹80 crores** to provide subvention for setting up dairy farm and animal unit at rural level for self-employment.
- A provision of **₹58 crores** to continue the services of mobile veterinary dispensary and make them more compact.
- A provision of ₹44 crores to provide benefit of cattle feed through *Khandan Sahay Yojana* to animal keepers during pre and post deliveries of their animals.
- A provision of ₹24 crores for Mukhyamantri Nishulk Pashu Saravar Yojana.
- A provision of **₹12 crores** for construction of milk house/godowns for rural milk producing cooperative societies.
- A provision of **₹8 crores** for *Karuna* Animal ambulance-1962.

Kamdhenu University

A provision of \gtrless 137 crores for management of Kamdhenu University and to provide impetus to agricultural research programs.

Fisheries

Total provision of **₹880 crores** for Fisheries Division.

- I announce the decision of the government to increase by 2000 litres the limit of diesel provided to fishermen at concessional rate across the board. A provision of ₹230 crores for the scheme *to exempt VAT on high speed diesel oil* for fishermen.
- A provision of ₹75 crores to provide interest relief on short term loans to fishermen.
- A provision of ₹201 crores to construct 5 new all-weather fishing ports at Nava Bandar, Veraval-2, Madhvad, Porbandar-2 and Sutrapada.
- A provision of ₹40 crores to provide modern equipment to fishermen and thereby increase their security and productivity.
- A provision of ₹264 crores for maintenance of the existing ports, strengthening the infrastructural facilities and to provide facility of floating jetty at Chorwad and Umarsadi.
- A provision of **₹30 crores** for *Pradhanmantri Matsya Sampada Yojana*.
- A provision of ₹25 crores to provide subvention for equipment to beneficiaries engaged in inland fisheries.
- A provision of **₹5 crores** for various schemes for providing infrastructural facilities to prawn fishing farms for development of brackish water fisheries.

Corporation

- A provision of ₹1250 crores for the scheme to provide interest relief to farmers for *Kharif and Rabi crops*.
- A provision of ₹50 crores for the management and strengthening of Agricultural Marketing System.
- A provision of **₹10 crores** for reviving co- operative sugar mill.
- A provision of **₹13 crores** for interest relief on short and long term credit to Sugar Cooperative Societies.
- A provision of ₹2 crores to provide trollies to porters in agriculture produce marketing committees for transporting goods.

Water Resources

Total provision of ₹5339 crores for Water Resources Division.

With majority works of **Sardar Sarovar Project** - the lifeline of the state - completed, the entire state has been bestowed with water security cover with irrigation facility of 69 lakh ha. of land in the state. Keeping in view the principle of *Per Drop More Crop*, State Government is making efforts to use water resources effectively.

- Works of 24 packages involving a total length of 1371 km. of *SAUNI Yojna* in Saurastra region have been completed and works of 7 packages involving 1150 km. long pipeline are under progress. Through these works 53 reservoirs, 130 lakes and more than 800 check dams have been filled up with the **Narmda** water. With the reservoirs catering to the need of drinking water in cities like Rajkot, Surendranagar, Botad, Morbi, Jamnagar, Bhavnagar, the drinking water problem of these cities has been largely resolved. A provision of **₹710 crores** for scheme.
- A scheme of ₹4369 crores has been approved to plan irrigation facilities with the help of an additional 1 million acre feet Narmada flood water in the Kutch region. In the first phase of this scheme, approximately 1 lakh 14 thousand ha. area of 6 talukas in Kutch district will get the benefit of irrigation. A provision of ₹272 crores for this scheme.
- It has been planned to construct big check dams, hydraulic structures for storage of water in phased manner in the next five years at the cost of ₹350 crores. A provision of ₹65 crores for these works.
- A provision of **₹93 crores** for Narmada based Kasara Dantiwada pipeline to be completed at an estimated cost of **₹1600 crores** under *Sujalam Sufalam Yojana* to provide the benefit of supplementary irrigation of Patan and Banaskantha districts.
- A provision of ₹70 crores for the ongoing pipeline works from Tharad to Sipu dam to provide benefit of supplementary irrigation to Tharad, Lakhani, Deesa and Dantiwada taluka of Banaskantha district.
- A total provision of ₹45 crores for 2 schemes i.e. the scheme to provide irrigation benefit through total 72 lakes of Malpur, Meghraj and Modasa taluka of Aravalli district from Vatrak river at an estimated cost of ₹186 crores and the scheme to provide irrigation benefit through 30 lakes of Bhiloda and Meghraj taluka by lifting water from the Meshwo reservoir located near Shamlaji at an estimated cost of ₹75 crores.

- A provision of ₹35 crores for Hirpur and Valasana barrage to be constructed on river Sabarmati at the cost of ₹200 crores.
- A provision of ₹30 crores to construct a barrage for developing the peripheral area of Dharoi dam as a world class tourist and pilgrim place, at the cost of ₹200 crores.
- It has been planned to undertake works at the cost of ₹200 crores in the next five years for recharging wells, networking of water resources, enhancing the capacity of lakes etc. in Kapadvanj, Kathlal, Mahudha, Galteshwar, Balasinor, Lunawada, Bayad taluka in phased manner. For this, A provision of ₹14 crores.
- A provision of ₹25 crores to provide benefit of irrigation to villagers which remain deprived of irrigation facilities in Sanand, Bavala and Viramgam taluka located around the bank of Nal Sarovar in Ahmedabad district.
- A provision of **₹19 crores** to dump the additional flood water of Narmada river into Mukteshwar reservoir by extending the Khorasam-Matpur-Dindarol pipeline.
- A provision of **₹15 crores** for the works of Poicha weir under the scheme to create irrigation and recharging facilities in Savli taluka of Vadodara district at an estimated cost of **₹308 crores.**
- A provision of **₹10 crores** for the scheme to fill up different lakes of Kadana, Santrampur and Lunawada taluka and for the works to fill up lakes of Santrampur Taluka through Kadana based pipeline.
- A provision of **₹161 crores** for the works of Tapi-Karjan link pipeline scheme which is in progress and is to be completed at an estimated cost of **₹711 crores** to provide irrigation facility to total 73 villages of Umarpada taluka of Surat district and Dediapada taluka of Narmada district.
- A provision of ₹160 crores for the works of the scheme to provide Panam high level canal/reservoir based irrigation facility in Panchmahal district, which is to be completed at an estimated cost of ₹452 crores.
- It is planned to construct big check dams/barrages/weirs on Par, Tan, Ambika, Daman Ganga etc. in South Gujarat in phased manner in the next five years at a cost of ₹500 crores For this, a provision of ₹94 crores.

- A provision of **₹195 crores** for irrigation distribution system by completing Songadh-Uchchhal-Nijar lift irrigation schemes, Kakrapar, Goradhavad, Karjan reservoir based pipeline.
- A provision of **₹70 crores** for the scheme of estimated **₹226** for increasing irrigation facilities by extending Kadana-Dahod pipeline.
- A provision of ₹35 crores to provide benefit to 23 villages under the lift irrigation scheme to fill up ponds of the villages of Santrampur taluka from Panam reservoir (near Vankadi village) at a cost of ₹133 crores.
- A provision of ₹25 crores for providing irrigation facility to approximately 1600 ha. area of 11 different villages of Kadana taluka in Mehsana district at a cost of ₹84 crores.
- Vagharej recharge scheme which aims to provide irrigation benefit to villages of Ganadevi taluka in Navsari district and drinking water to Bilimora Municipality and surrounding villages, arresting salinity from the ocean and recharge the groundwater table at a cost of ₹250 crores.
- Construction of tidal regulator on river poorna near Viraval-Kasbapar at the cost of **₹250 crores.**
- A provision of ₹20 crores for developing Karli recharge reservoir area as a place of natural beauty and to strengthen the work of controlling salinity ingress.
- A provision of **₹8 crores** for constructing a weir for the purpose of arresting salinity ingress and conservation of water in Kutch.

Bhadbhut Barrage

Works have started for the ambitious *Bhadbhut Barrage* to construct a sweet water reservoir on river Narmada at a cost of ₹5322 crores A provision of ₹1240 crores for this scheme.

Narmada Project

Total provision of **₹6090 crores** for the Narmada Project.

Construction of Sardar Sarovar Dam has been completed in the year 2017. The water stored in Sardar Sarovar reservoir is used for irrigation, generating hydraulic power, drinking and industrial purposes. It has been planned to complete the works of Kutch branch canal and its ancillary network to take Narmada water to Mandvi taluka. Besides, special planning has been made for strengthening the existing canals of Narmada Project in north Gujarat and complete the missing link in Saurashtra.

Micro Irrigation

By taking an initiative in micro irrigation, Gujarat has made remarkable progress. With this method, more production can be achieved with economic use of water. In the last two decades, 13 lakh farmers have been benefited by putting in place micro irrigation in approximately 21 lakh ha. Area. A provision of **₹500 crores** for expanding the scope of this scheme in further 1 lakh ha.in the next year.

Water Supply Total provision of ₹5451 crores for Water Supply Division

State-wide water supply grid has been created to provide safe drinking water in adequate quantities in more than 14 thousand rural and 238 urban areas of the state More than 14 thousand rural areas have been linked to the grid. **With 93 percent achievement in the** *Nal se Jal Yojana* **implemented by Honourable Prime Minister Shri Narendrabhai Modi,** Gujarat ranks first in the entire country. Government is committed to provide clean drinking water to the remaining villages and cities to achieve a 100 percent target in near future. Further, different projects have been put into implementation for ensuring underground drainage systems in urban areas and treating the sewage water for recycling.

- Total planning of ₹5540 crores including ₹2500 crores as the share of Central Government and ₹3040 crores as the share of State Government for providing clean drinking tap water in every household through *Har Ghar Jal Yojana* under *Jal Jeevan Mission*.
- A provision of ₹709 crores for 123 works under the Group Water Supply Scheme of ₹6653 crores which is under progress to provide drinking water facility to 6627 villages.
- Works at an estimated cost of ₹1020 crores are under progress for laying 143 km. long bulk pipeline from Navada, Botad, Gadhda, Chavand and from Budhel to Borda to strengthen the drinking water facility in Saurashtra region. A provision of ₹310 crores for these works.

- Works at an estimated cost of ₹1044 crores are under progress for laying long bulk pipeline from Bhavnagar, Gir-Somnath, Amreli, Botad, Junagadh, Rajkot and Porbandar to strengthen the drinking water facility in Saurashtra region. A provision of ₹500 crores for these works.
 - A provision of ₹400 crores for installing desalination plants of 27 crores litre (270 MLD) capacity at four different places to provide water security to the remote coastal villages of Saurashtra and Kutch regions.
 - A provision of ₹100 crores for treatment of sewage water in urban areas and reuse the same under the Reuse of Treated Wastewater Policy.

Health andTotal provision of ₹12,240 crores for the Health and FamilyFamilyWelfare Department

Welfare

Health is a primary requirement for social and economic development and a healthy and happy individual. Our government accords priority to easy access of both, the primary health care services and specialised treatment in serious diseases.

Public Health, Family Welfare and Medical Service

- A provision of ₹45 crores for making sanitary pads available free of cost to generate awareness about menstruation among adolescent girls and women.
- Because of deficiency of iron, adolescent girls tend to be anaemic. In future, the scheme to administer iron sucrose to pregnant girls will also be included to monitor the level of haemoglobin and fix iron deficiency in girls entering puberty. For this a provision of **₹5 crores**.
- A provision of **₹20 crores** under *Bal Amrut Poshan Yojna* to provide comprehensive nutrition to children.
- A provision of ₹5 crores to make 90 new *Khilkhilat* vehicles available to safely reach the new born child and the mother to their home.
- A provision of **₹150 crores** for enhancing the scope of *Pradhanmantri Matru Vandana Yojana* to provide nutritional aid to pregnant mothers and children.

- To further strengthen health care services in urban areas, CHCs and PHCs have been made functional. All the remaining CHCs and PHCs in these areas will be started as planned. Further, 1238 new posts of health workers will be created in these centres. For this, a provision of **₹16 crores**.

- A provision of ₹30 crores from among the planning of ₹200 crores for modernization of SG hospital for providing all the medical facilities to the patients for intensive treatment of Spine, Kidney and Ophthalmic deceases.
- A Provision of ₹23 crores from among the planning of ₹150 crores for establishing ultra-modern Cardiac Cath Laboratory and Hospital at Vadodara for treatment of patients suffering from serious cardiac deceases.
- A provision of ₹68 crores from among the planning of ₹450 crores for renovation of Civil Hospital, Ahmedabad with facility of 900 beds.
- A Provision of ₹23 crores from among the planning of ₹150 crores for new OPD building and extension of existing facility in Civil Hospital, Surat.

Keeping in view the requirement of women and children for health and nutrition, Government has implemented the grass root level Anganwadi scheme. Through these schemes, Government intends to bring all the stages of the life cycle under the ambit of these schemes and ensure balanced, physical and mental development. Considering the importance of this section of the society, I propose **42 percent** increase before the house compared to the provision of the last year.

- A provision of **₹811 crores** for the next year under *Suposhit Mata-Swashth Bal Yojana* to provide one kg. Tur Dal, 2 kg. gram and one litre edible oil free of cost upto 1000 days to pregnant and lactating mothers.
- A provision of **₹1153 crores** for nutrition, pre-education and other facilities of children under Anganwadi Program.
- A provision of **₹1059 crores** for door to door *Sukhdi* distribution to children in the age group of 3-6 and to provide **"take home ration"** to adolescent girls and pregnant, lactating mothers.
- The norms to provide economic assistance to widows have been liberalised by the government. As a result, the number of women under this scheme has increased from 1.5 lakh to 11 lakh in three year A provision of ₹917 crores to provide assistance under the scheme.

Consumer Affairs Department

It is the priority of our government to ensure food security for every family of the state and provide food grains and other essential commodities at concessional rates to the 70 lakh families registered under National Food Security Act. In the horrific situation created because of the covid-19 pandemic, our government has accomplished the herculean task of providing 28 lakh tonne of food grains free of cost to all the families registered under NFSA through Pradhanmantri Garib Kalyan Ann Yojana launched bv Honourable Prime Minister. By making available online through My Ration Mobile App the details of the stock lifted by every family, government has made an effort to bring ease and transparency in the Public Distribution System through its digitisation. This process will be further accelerated and electronic weighing scales will be made available in fair prise shops in the state. Compared to the provision of the last year, a substantial increase of 24 percent has been proposed in the provision of the department this year.

- A provision of **₹621 crores** for food distribution under Public Distribution System to the families registered under NFSA.
- Under the Public Distribution System, government has started the scheme to distribute *tur dal* to the families registered under NFSA to increase the intake of protein in their meal. Earlier, subsidy of ₹20 per kg. of Tur dal was given which resulted in disadvantage to the beneficiaries because of fluctuation of market rates.
