Poet Bakibab Borkar summed up the dream of Goans in these words during the pre-liberation era. Today, as the whole of India and the State of Goa move towards the centenary celebration of independence, we aim in promoting good governance on the principles of Antyodaya, establishing new parameters of all-round development, moving from the "Amrut Kaal" to "Kartavya Kaal" with a desire to realise a "Vikasit Bharat" by 2047.

Successful implementation of Swachh Bharat Yojana, continuous expansion of Make in India, skyrocketing of Chandrayaan Mission in the field of astronomy, creation of highway networks in all remote areas of the country, expansion of educational institutions like IIT/ AIIMS/IIM, strengthening the rural economy through the Atmanirbhar Bharat Yojana, abrogation of Article 370 of the Constitution, introduction of the Nari Shakti Bill that empowers women to become people's representatives, removal of The Indian Penal Code and the Criminal Procedure Code which was the legacy of the British Raj, the easy availability of bio-fertiliser and nano-technology to the farmers to increase the agricultural productivity of the country etc. with the mission of "Sabka Sath, Sabka Vikas, Sabka Vishwas, Sabka Prayas" has been achieved by the Hon'ble Prime Minister Shri. Narendra Modi, to whom I express my gratitude on behalf of the people of Goa.

Manohar International Airport, Atal Setu, GMC Superspeciality Block, New Zuari Bridge, Central AYUSH Hospital, NIT Campus, National Forensic Science University Campus, etc. provide the glimpse of the "Double Engine" impact of the Central and the State Government.

Friends, on 09 January 1964, the first Legislative Assembly of the Union Territory of Goa, Daman and Diu was constituted. It has been 60 years for this landmark historic event. During this six-decade tenure, Late Bhausaheb Bandodkar, Late P.P. Shirodkar, Late Narayan Fugro, Late Jack de Siquera, Late Dr. Kashinath Jalmi, Late Sasikala tai Kakodkar, Late Dr. Wilfred D'Souza, Late Manohar bhai Parrikar, Shri. Pratapsinh Raoji Rane, Shri. Shripad Naik, Shri. Ravi Naik, Shri. Ramakant Khalap such senior, studious

and efficient leaders have enhanced the prestige of this House as a representative of the people of Goa. I express my humble gratitude to all the former and the present MLA's on this occasion.

With the desire for a bright future of the State of Goa, which practically implements Uniform Civil Code, an embodiment of Ek Bharat Shreshtha Bharat, inter-religious unity in action and the continuous support and blessings of the people of Goa, I stand in this august House of the Goa Legislative Assembly to deliver the budget of the State of Goa for continuous fifth time in a row as the Chief Minister of the State of Goa, with the intention of creating a golden era for Goa, a knowledgeable, capable and dynamic Goa as well as a truly Swayampurna Goa.

FISCAL PROFILE

The Gross State Domestic Product (GSDP) of the State of Goa for the year 2023-24 (advance) at current prices is estimated at ₹1,06,532.57 crore with a projected growth rate of 13.73% as compared to 11.16% for the year 2022-23. Consequently, Goa has an estimated GSDP per capita of ₹6.75 lakh for the year 2023-24 in the country, portraying a robust and healthy economy.

The GSDP for the year 2024-25 is projected at ₹1,21,309.02 crore at current prices with a robust growth rate of 13.87% as compared to the year 2023-24 and a Per Capita Income of ₹7.64 lakh. The enhanced growth rate is expected due to various factors such as the commissioning of the Mopa Manohar International airport which will enhance global connectivity through new routes to meet the increasing travel demand to Goa.

Speaker Sir, the total estimated receipts for the FY 2024-25 stand at Rs.26,465.02 crores as against Revised Estimate of Rs.25,258.36 crores in FY 2023-24. The anticipated expenditure for FY 2024-25 is Rs. 26,850.56 crores.

Speaker Sir, I am happy to announce that the State Government has received funds of around Rs. 750 crores as special assistance from Government of India. This is a testament to the "Double Engine" sarkar which is focussed on Antyodaya, Sarvodaya and Gramodaya. This year we expect Assistance to the extent of Rs. 1,506.56 crores as assistance from the Central Government for various schemes.

Speaker Sir, the various fiscal reforms undertaken by my Government have started to show the results in the State Government Accounts. In FY 2022-23,

Goa has achieved a revenue surplus of Rs. 2,399.21 crores as per the State Finance Accounts provisionally vetted by CAG. It is the first time in the history of this State that we have achieved such a large revenue surplus. The projected revenue surplus for FY 2024-25 is Rs. 1704.19 crores. We will continue on our path of development and continuously strive for betterment of the public without compromising on the fiscal health of the State.

Speaker Sir, Ministry of Finance, Government of India has capped the Fiscal Deficit to GSDP ratio at 3.5% of GSDP for FY 2024-25. As per the recommendations of 15th Finance Commission, the unutilized borrowings of previous financial years are allowed to be carried forward. Considering this, the Fiscal Deficit of the State for FY 2024-25 is projected to be Rs. 3,149.46 crores, which is well within the limits set under the FRBM Act.

PLANNING AND STATISTICS

Speaker Sir, the allocation for the Planning and Statistics Department for FY 2024-25 is Rs. 43.07 crores.

Speaker Sir, we have successfully established a Data Analytic Cell which gives crucial inputs in decision making by analysing various datasets across departments. Through this cell, we were able to add more beneficiaries in existing schemes, eliminate ineligible beneficiaries from different schemes and also ensure better analysis of multiple data points from various departments. For continuing these efforts in order to have better governance, a provision of Rs. 10 crores has been made. As assured, Call Center for reviewing Government programmes has been made functional in this Financial Year.

Speaker Sir, under the Swayampurna Goa program, Village Panchayat-wise special Aadhaar enrollment drives are being undertaken during the year. 79 nos. of Village Panchayats have been covered across catering to 6,676 nos. of residents.

The Hon'ble Prime Minister's Viksit Bharat Sankalp Yatra has reached every village panchayat and municipal wards in the State of Goa. I am pleased to inform you that these efforts have led to 100% saturation in the majority of the flagship schemes of the Government of India.

Goa implements Direct Benefit Transfer of benefits both in cash and in kind to the beneficiaries of 165 nos. of schemes (61 nos. of centrally sponsored and 104 nos. of State schemes) using Information & Communication Technology (ICT). A budget provision of ₹75.10 lakh is proposed for the F.Y. 2024-25 for all Aadhaar related activities.

Swayampurna Goa Program 2.0

Spearheaded by the resounding success of Swayampurna Goa 1.0 initiative and in order to continue the mission of Antodaya, Sarvodaya and Gramodaya for transformation of every Goan citizen into a self-reliant individual contributing towards a self-reliant Goa, Swayampurna Goa 2.0 was launched in April 2022 under the theme "Mission with Vision".

During the year 2023-24, Special drives were undertaken at the Village Panchayats/Municipalities/Corporation in coordination with Government departments and Swayampurna Mitras with an effort to reach Government schemes/services to every resident. More than 15,000 nos. of residents have benefited through these special drives.

Training programmes on food processing, coir item making, tailoring and other trades are conducted at regular intervals to empower village people under Hon'ble Chief Minister's vision of skilling, re-skilling and up-skilling of Goans to make Goa a skilled hub.

The Government has adopted a unique practice of conducting theme based webinars on monthly basis for creating awareness among the Swayampurna Mitras, prospective beneficiaries and public at large about the schemes. More than 15 nos. of such live interactions/webinars have been conducted at Village Panchayat /Municipality level.

Swayampurna Goa e-Bazaar

Speaker Sir, we have successfully launched Swayampurna Goa e-Baazar on 24th November 2023 which provides the local artisans, Craftsmen, specially Mahila Self Help Groups, a platform to more than 46,000 members of Self Help Groups registered with the State Department of Rural Development and Urban Development and to around 12,000 nos. of Artisans/Craftsmen registered under the Department of Handicraft, Textile and Coir.

Swayampurna Goa Board

My Government has constituted the Swayampurna Goa Board which will define policies to make Goa self-reliant and also develop strategies to ensure that the vision of "Antyodaya, Sarvodaya and Gramodaya" is achieved in the minimum possible time span.

A budget provision of ₹10.50 crore is proposed for the F.Y. 2024-25 for all activities related to Swayampurna Goa Programme.

Goa Corporate Social Responsibility (CSR) Authority

My Government has created the Goa Corporate Social Responsibility (CSR) Authority to ensure regular receipt of CSR funds from the corporate entities to enable the Government in using these CSR funds uniformly throughout the State to benefit all sections of society for their betterment. The list of MoUs signed with various prestigious institutions by the Goa CSR Authority is as at Annexure - 1.

A budget provision of ₹25.00 lakh is proposed for the F.Y. 2024-25 towards this Goa CSR Authority.

Chief Minister's Fellowship Program (CMFP)

Speaker Sir, the Goa Chief Minister's Fellowship Program to identify and motivate talented young minds by involving them in the process of the public administration system to prepare them for greater leadership and professional roles in the social and economic development of the State has seen resounding success and the number of fellows have been increased to 20 Fellows. A budget provision of ₹93.00 lakh is proposed for the F.Y. 2024-25.

For the Goa Institute of Future Transformation,a budget provision of ₹82.00 lakh is proposed for the F.Y. 2024-25.

Sustainable Development Goals (SDGs)

The State of Goa has performed excellently in all spheres which has been aptly reflected in the Sustainable Development Goals (SDGs) Index 3.0 wherein Goa has become the Achiever in 2 nos. of Goals, Frontrunner in 8 nos. of Goals, Performer in 3 nos. of Goals and Aspirant in 2 nos. of Goals.

Creation of a dedicated Cell for Central Schemes

My Government has created a dedicated CSS Cell so as to identify new Central sector and Centrally sponsored schemes by regularly coordinating with the Central Ministries and the concerned State Departments for fast tracking of approvals as well as dovetailing of schemes and also to maximise the inflow of Central funds. As a result of this we were able to get Central

funds to the extent to Rs. 5,395 crores in FY 2022-23 as against Rs. 4,304 crores in FY 2021-22, an increase of 25.34%.

FINANCE

Speaker Sir, the CMRY scheme has been modified to meet the recent developments or new sectors of the economy. Further, the Mukhyamantri Modified Interest Rebate Scheme has also been notified to meet the current industry requirements. For these schemes, provision of Rs. 6.50 crores has been made.

Speaker Sir, as assured, we have empanelled various banks for better e-governance and delivery of public services. Majority of the benefits under various schemes are now being timely disbursed due to this mechanism. I propose to extend the same mechanism to all schemes in this financial year.

Speaker Sir, the focus of this budget is on infrastructure development in tourism, information technology, industries and employment. For streamlining the infrastructure approvals, the entire procedure of sanction will be revamped. Also, an IT team shall be deputed in all the works department for infrastructure mapping and monitoring of the works carried out.

GENERAL ADMINISTRATION

Speaker Sir, the budget allocation for the General Administration department has been increased to Rs. 166.60 crores.

Speaker Sir, to hear the public directly, we have already taken various measures such as the CMs helpline, strengthening of the public grievances cell etc. I also hear the general public during the Hello Goenkar programme on the first Friday of every month. Further, all my cabinet colleagues also visit various Talukas in the Janata Darbars held occasionally. All these are the initiatives of my Government to effectively resolve public grievances and ensure an accountable and corruption free governance.

GIPARD, the State's Apex Training Institute for training, capacity building, research and consultancy activities has conducted 226 Training Programmes for 8,578 participants during the period April to December, 2023. The new institutional block of GIPARD will be completed in the year 2025. To achieve the vision of Hon'ble Prime Minister "Mission Karmayogi" i.e training of manpower, the total allocation to GIPARD is Rs. 2.50 crores.

Speaker Sir, the work of the State of the art Prashashan has commenced and is expected to be completed in the next 3 years. For this purpose provision of Rs. 30 crores has been made.

Speaker Sir, the renovation work of the Samadhi of first Chief Minister of Goa Late Shri Dayanand Balkrishna Bandodkar situated at Miramar will be taken up through GSIDC at an approximate cost of Rs. 10 crore.

Speaker Sir, the Housing Loan Scheme for Government Employees will be re-introduced in FY 2024-25 which will provide loans at subsidised rates to Government Employees. An amount of Rs. 15 crores has been earmarked for this scheme.

<u>HEALTH</u>

Speaker Sir, the allocation to the entire Health Sector is Rs. 2,121.86 crores.

GOA MEDICAL COLLEGE

Speaker Sir, the allocation to Goa Medical College is Rs. 1,071.35 crores of which Rs. 890.25 crores is on the revenue side and Rs. 181.10 crores is for capital expenditure.

Speaker Sir, GMC has been continuously achieving various milestones year after year. The Department of Orthopedic, GMC was 1st Government Hospital in the Country to start Robotic Knee replacement surgery. Virus Research and Diagnostic Laboratory lab in Microbiology department is ready and will be commenced shortly. Also, the Cardiology Department will be starting Trans catheter Aortic Valve Implementation (TAVI) for patient with severe Aortic Stenosis in this year.

Speaker Sir, I am pleased to state that the Central Government has sanctioned an amount of Rs. 3.10 crore for Goa Medical College for carrying out research in various departments and skilling of Doctors and Nurses under the skill centre established in GMC which is one of the twenty National Emergency Life Support Skill Centers setup across country.

HEALTH SERVICES

Speaker Sir, the allocation for Directorate of Health Services is Rs.838.47 crores.

Speaker Sir, the 50 Bedded AYUSH Integrated Hospital in South Goa will be completed in the financial year 2024-25. In order to upgrade the health

infrastructure, the projects attached as Annexure –A will be taken up across the State for which a total capital outlay of Rs. 55.50 crores has been provided. Under the National AYUSH Mission, I propose to undertake focused study of Adolescent Anaemia, Mother and Child healthcare and introduce eye care under AYUSH Ophthalmic OPD at Primary Health Center, Shiroda.

DENTAL COLLEGE

Speaker Sir, the allocation for Dental College is Rs. 75 crores.

Speaker Sir, in order to reduce hardship to citizens visiting Dental College, I propose to Digitalize the OPD section. Post Graduate course in Public Health Dentistry is also expected to commence in Goa Dental College. I also propose to upgrade the satellite clinics under the Goa Dental College & Hospital to render them self-sufficient. The construction of Hostel to accommodate Post Graduate students of Goa Dental College and Hospital will be completed this year at a cost of Rs. 15.48 crores.

INSTITUTE OF PSYCHIATRY AND HUMAN BEHAVIOUR

Speaker Sir, the allocation to IPHB has been increased to Rs. 82 crores.

Speaker Sir, the Day Care Centre for Mentally ill patients will be commissioned by the end of this year 2024. Patients will be taught various skill based vocational activities such as yoga, tailoring, carpentry, bakery, flower making, printing, handicrafts embroidery, candle making, art and craft etc., to make them meet their livelihoods.

Speaker Sir, the new 100 bedded facility built with Central Assistance will be commissioned by the end of the year 2024. The facility will include geriatric wards, paediatric wards, Psychiatric ICU for male and female and also wards for Mentally ill Prisoners.

PWD

Speaker Sir, allocation to the Public works Department has been increased by 10.75% and is Rs. 2,976.55 crore.

Speaker Sir, today each and every Goa is proud of the infrastructure marvel "New Zuari Bridge". The project also exemplifies our commitment to the development of State of the Goa and to adopt latest technologies which is adopted in the construction of this bridge. The work of observatory towers with viewing galleries costing around Rs. 270 Crores will commence soon which will be a major tourist attraction. Also, the work of Porvorim elevated corridor on NH-66 costing around Rs. 641.46 Crores will begin soon.

Speaker Sir, the ongoing National Highway Projects planned in the State of Goa marks the importance of our "Double Engine Sarkar" which could be possible only due to active support of our Hon'ble Prime Minister and Hon'ble Union Minister for Road Transport & Highways.

Speaker Sir, my Government has proposed 10 works amounting to Rs. 350.34 Crores under the Central Road Infrastructure Fund and we are confident to receive early sanctions from the Union Government and all these projects are

on 100% reimbursement basis. The details of the projects are as per Annexure B.

Speaker Sir, my Government will focus on new Road improvement initiatives which will include comprehensive road safety measures, condition survey of all the bridges/culverts, road safety audit plan to identify deficiencies and suggest remedial measures, annual maintenance contract of road safety equipments including crash barrier installation and filling up of potholes on fast track basis For which an outlay of Rs.50 Crores has been provided. The planned improvement of riding quality surface will be undertaken for more than 1,000 kilometres with an outlay of Rs. 840 Crores.

Speaker Sir, I propose to construct a model housing complex at Altinho which will be a multi-storeyed structure housing 20 "B" and 20 "C" type Government Quarters which will have all the modern amenities, use of solar power, use of recycled water, rain water harvesting, parking and an outlay of Rs.20 Crores is earmarked to take up this model housing project.

Speaker Sir, my Government has taken a decision to ensure that 100% sewer connections are achieved wherever sewerage schemes are in operation and an outlay of Rs. 250 Crores is planned to achieve this target and complete all the ongoing sewerage schemes on priority in next one year.

Speaker Sir, my Government is in the process of achieving the distinction of becoming a smart water utility State and the key focus will be on Non Revenue Water Reduction Programme. In order to implement this, I propose to take up a pilot project with an initial outlay of Rs. 1.50 Crores which will also include advanced metering infrastructure, replacement of age-old water supply pipelines which have outlived its useful life, GIS network, geo-tagging up to consumer level and smart water management in the project area. I also propose to take up-gradation measures at Water Treatment Plants, improvement at water supply installations and other allied works with an outlay of Rs.100 Crores.

Speaker Sir, my Government with its commitment to ensure all round development of the State has implemented a Uniform Budget Plan wherein each Assembly Constituency is earmarked with an allocation of Rs 40 Crores for each financial year. This has facilitated all the members of this house to plan developmental works and other minor works in an efficient manner in their respective Assembly Constituency. The total outlay for each financial year stands now at Rs 1,600 Crores.

Speaker Sir, I propose to take up complete refurbishment and renovation of Goa Bhavan at Mumbai and Goa Sadan & Goa Niwas at New Delhi including day to day operations & maintenance at an outlay of Rs.42.96 Crores and is expected to be completed within one year.

Speaker Sir, in addition to projects which are under execution, additional new 155 projects will be taken across various sectors in Roads, Sewerage and Water Supply totalling to Rs.250.00 Crores. Some of the major projects proposed to be undertaken as at Annexure- C.

Speaker Sir, 677 new projects are proposed for execution totalling to Rs.1,600 crores in this Financial Year. List of major projects under Water Supply, Sewerage, Roads, and Buildings and the list of major projects are as at Annexure – D.

Speaker Sir, Ministry of Jal Shakti, Government of India has recently sanctioned 1 project viz., Pollution Abatement and Conservation of Zuari river at Curchorem and surrounding areas in Goa under National River Conservation Plan costing Rs.81.14 Crores.

For undertaking all these Capital Works, a capital outlay of Rs. 778.88 crores has been provided to the Power Department.

Speaker Sir, Ministry of Power, Government of India, has approved DPR for Loss Reduction / System strengthening works amounting to Rs. 243.43 Crores with Gross Budgetary Support (Grants) of Rs. 146.06 Crores under Revamped Distribution Sector Scheme.

The Ministry of Power has also approved DPR for Smart Metering Works amounting to Rs. 467.42 Crores with Gross Budgetary Support (Grants) of Rs. 96.43 Crores. Works amounting to about Rs. 290 Crores under these packages are in progress.

The work for Installation of about 7.5 Lakhs Pre-paid Smart meters sanctioned under RDSS will start during the FY 2024-25. Besides this, we are in the process of submitting DPR for Phase II of Revamped Distribution Sector Scheme, RDSS for SCADA and Modernization / upgradation. Various new / upgradation of existing substations, transformers, HT and LT lines, Distribution transformer centres and Ring Main units.

NEW AND RENEWABLE ENERGY

Speaker Sir, the allocation to New and Renewable Energy has been increased to Rs. 62.94 crores.

A new scheme for giving free solar Power Pumps for irrigation purpose installations of rooftop power plants on the roof of SC/ST households with 25% share from the beneficiary and free installations of Solar Street Lights in all SC/ST inhabited areas for public use.

Speaker Sir, for Electric Vehicle subsidy and also for setting up infrastructure related to EV, an amount of Rs. 25 crores has been earmarked.

Speaker Sir, this year I propose to implement the Green Hydrogen Scheme through GEDA. I also propose to organise a Skill Development Programme for upskilling the human resource in the renewable energy sector. Further, all necessary support will be provided to migrate to CNG.

Under the Concentrative Solar Technology (CST) systems, my government has proposed to install Solar thermal plants at ASILO and HOSPICIO hospital to substitute the use of fossil fuels.

I propose to install Solar Rooftop on the Govt. Building / Institutions and Govt. Aided Schools with total capacity of 30 MW on PPP basis. I also propose to have a Virtual Net Metering project in Govt. School

Further, setting up of a 5 MW floating membrane solar Power Plant and 100 MW wind Power Plant is in process.

WATER RESOURCES

Speaker Sir, the allocation for the Water Resources Department is Rs. 670 crores.

Speaker Sir, to carry out an overall study of the sources of water and rivers in the state along with their conservation, I propose to launch a new programme "Nadi Parikrama- Ugam Se Sangam" for which a provision of Rs. 5 crores has been made. This will consist of nature trails, drone shoots, river health monitoring and natural waste for river conservation. For this purpose, assistance from expert institutions such as NIO will be sought.

Speaker Sir, a study is being conducted under the National Water Mission to identify and map the water resources and estimate the water requirement state by the year 2047. Preliminary estimates have projected state water demand to about 31.64 TMC.

In order to meet this requirement, my Government proposes to take up key projects to harvest and develop water availability in the state by initiating the following projects:

Speaker Sir, due to the initiative taken by my Government, I am pleased to inform you that the Government of Maharashtra has agreed in principle to study the feasibility of enhancing water the storage of Tillari Dam by 5.34 TMC.

Speaker Sir, my Government proposes to commence the feasibility studies and consultancy for preparation of DPR for Construction of 6 New Dams in the state to store about 15 TMC of water for Irrigation, Industrial and Drinking Water Purpose at a cost of Rs. 50 crores.

Speaker Sir, under National Cyclone Risk Mitigation Programme III of Government of India, we expect financial aid to the extent of Rs 247.77 Cr. for Flood control and drainage improvement measures for Panaji city and surrounding areas, Improvement to saline bunds and Development of Mangrove plantation

Speaker Sir, under the Dam Rehabilitation and Improvement Project which is a World Bank Aided project, it is proposed to conduct a Safety Audit of the dam and take up their rehabilitation and improvement on the recommendation of Dam Safety Panel (DSP) for ensuring their longevity and safety at an estimated cost of Rs. 58 Crore.

Speaker Sir, it is also proposed to strengthen and carry out improvement to Tillari Irrigation Left bank main canal and right bank main canal in Goa and Maharashtra State at an estimated cost of Rs. 400 Cr.

Speaker Sir, I also propose laying of 60 MLD raw water pipeline from Assnora plant to Guirim, Mapusa at an estimated cost of Rs. 50 Cr.

TRANSPORT

Speaker Sir, the allocation to the transport department is Rs. 306.09 crores.

Speaker Sir, I am pleased to inform the august house that due to the proactive efforts of our Chief Secretary, who is a distinguished IIT Alumni, Goa will get an anticipated social impact fund contribution of Rs 2,500 crores for which the discussions are ongoing under the CSR initiative of the Global IIT Alumni hub. Goa will also be developed as a transportation hub with an anticipated social impact fund contribution of Rs 700 crore which will be in the form of Viability Gap Grant Funding. Due to this initiative, the entire fleet of Kadamba Transport Corporation will be replaced with battery operated Electric Vehicles thus drastically improving the transport scenario in Goa. This will also contribute significantly to expanding the tourism economy of Goa by reducing seasonality, increasing the area of the tourism zone and enhancing the ratio of high spending tourists.

Redevelopment of KTC Bus Stand at Bicholim, Goa at a cost of Rs. 20 crores will be completed by December 2024. The proposed allocation for construction of Bus stands at Vasco & Margao is Rs.6.50 crores. It is proposed to engage transaction advisories for upgradation of bus stands through PPP mode. I also propose to introduce 50 Buses on the Interstate Route and add another 50 Buses for augmentation of the fleet.

Speaker Sir, my Government has already requested MoRTH to provide Electric Buses under Gross Capital Contract Scheme. We are awaiting sanction of the same from the Central Government. I also propose to implement ITMS i.e Modernisation of Transport which will comprise of Depot Management System, Document Management System, Command & Control centre at Panaji Bus Stand.

CAPTAIN OF PORTS AND RIVER NAVIGATION

Speaker Sir, the total allocation for these departments is Rs. 156.99 crores.

Speaker Sir, the construction of the State-of-Art Iconic Captain of Ports Terminal Building is scheduled to be completed in 2024-25, at a cost of Rs.

25.20 crores. In order to facilitate free movement of Vessels, dredging at the mouth of **River Chapora**, desilting of **River Mapusa** is proposed to be taken up. This will also prevent flooding in low lying areas and facilitate Navigation.

I proposed to upgrade and develop the existing network of 06 Lighthouses and 15 Beacons in the state, including Lighthouse at Campal with GRP or equivalent structure with advanced technology. Under the **Sagarmala Scheme** Seven Coastal Passenger jetties are proposed and approved in the River Mandovi, River Zuari, River Mapusa and Kumbharjua Canal at an estimated cost of Rs.60.03 crores. We also intend to replace 4 old Ferry Boats with new ones in FY 2024-25.

SPORTS AND YOUTH AFFAIRS

The total allocation to Sports and Youth Affairs is Rs. 240.70 crores.

Speaker Sir, we have successfully organised "National Games" in Goa in October 2023. We have won a record 92 medals in National Games and this has been a landmark achievement in the sporting history of Goa.

Speaker Sir, in line with Khelo India Centres of Excellence, I propose to open Khelo Goa Centres, one in each taluka, where training in multiple disciplines of sports will be provided across all the centres. For this purpose, an allocation of Rs. 30 lakes has been made.

In order to continue our support to the sporting fraternity by upgrading the infrastructure, I propose to take the infrastructure works which are at Annexure – I, for which a provision of Rs. 36 crores has been made.

I also propose to undertake the development of sports playgrounds and sports infrastructure at Poriem, Vasco, Savoi Verem, Mandrem, Goa Velha, Cumbharjua for which the estimates preparation is under progress.

PANCHAYATS

Speaker Sir, the allocation to Panchayats is Rs. 313.32 Crore. The State Finance Commission has already submitted its major recommendations to the Government. Based on the recommendations, the Government in this Financial Year will decide on the quantum and methodology to devolve grants to local bodies. Until such time, my Government will continue to provide financial support to the local bodies.

Speaker Sir, my Government will provide the services of House Tax Collection, Trade Tax Collection, Water and Electricity NOC, issuance of Income certificate, Residence certificate, trade licence, sign board licence, birth and death certificates in online mode which will ease the burden of citizens who have visit their respective Village Panchayats to pay fees and to obtain NOCs/Certificates mentioned above. This will also encourage paperless workflow at Village Panchayats.

To support the financially weaker Village Panchayats, financial Assistance of Rs.13.15 crores has been provided. For Infrastructure Development like construction of Roads, Pathways with pavers, community hall etc. an allocation of Rs.17.49 crores has been given.

Under Deendayal Infrastructure Development Scheme for various works like, Panchayat Ghar, Community Hall for Panchayat, Panchayats PlayGrounds, Panchayats complexes for market and other purpose etc. an allocation of Rs.7.50 crores has been made. For Swachh Bharat Mission Gramin which allows the construction of a Material Recovery Facility (MRF) an allocation of Rs.83.33 crores has been provided. To continue our Swachhata mission by providing Bio-Digester Toilets to Individual Household as well communities at subsidised rate in rural areas, an allocation of Rs.8.50 crores has been made.

Speaker Sir, to strengthen the Zilla Panchayats, a total amount of Rs. 16 crores has been allocated for various purposes. I also propose to revise the honorarium to ZP members which has not been revised recently.

RURAL DEVELOPMENT

Speaker Sir, the allocation for the Rural Development Department is Rs. 69.97 crores.

The work of Goa Bazaar project worth Rs. 16 crores with Central Assistance will commence from this Financial Year.

Speaker Sir, my Government has sanctioned all the 257 houses targeted under Pradhan Mantri Awas Yojana - Grameen (PMAY-G) "Housing for All".

Speaker Sir, to create sustainable livelihood opportunities for the rural poor i.e.women Self Help Groups (SHGs), I propose to form 18 Cluster Level Federation (CLF) consisting of 1,000 to 1,500 SHG Members in each CLF having its independent Office & Human Resource and also each CLF will plan their own Business Development Plan and Annual Action Plan.

In order to start the income generating activities, the Community Investment Fund of Rs.1.50 lakhs will be given to each SHG and for 2024-25, 500 SHGs will be provided with this fund. To setup the Office of Cluster Level Federation (CLF) the amount of Rs.3.50 lakhs- will be given to each CLF i.e. 18 CLF as a Start up Fund.

Speaker Sir, we have successfully launched the "Mukhyamantri Annapurna Yojana," to support women self-help groups (SHGs) in Goa to become entrepreneurs by running the Canteen or providing Catering services for various Government Departments and State Government Offices. Till date 25 SHGs have been empanelled under the scheme and for the financial year 2024-25, 50 SHGs will be empanelled for providing Canteen & Catering Services.

URBAN DEVELOPMENT

Speaker Sir, the allocation for the Urban Development department is Rs. 404.09 crores.

Speaker Sir, under AMRUT 2.0 mission, it is proposed to implement 24 projects for various water supply works. Rs 173.42 crores have been sanctioned under the mission. Further, under Swachh Bharat Mission–Urban

Speaker Sir, I am pleased to inform this august house that under the Swachh Sarvekshan Awards 2023, Panaji has been ranked No. 1 as the fastest moving city nationwide category and Sankhali has been declared as the Cleanest city in Goa. For CCP and Sankhali municipality, assistance to the extent of Rs. 10.75 crores and Rs.5 crores has been earmarked.

Speaker Sir, under the CSS Deendayal Antodaya Yojna National Urban Livelihood Mission benefits to the extent of Rs. 6.96 crores have been extended to 1,144 beneficiaries.

Speaker Sir, the GIS survey of North Goa ULBs has commenced and is scheduled to be completed by 31st March, 2024. From this year, we will also commence a GIS survey of South Goa ULBs. This will assist the councils in identifying all unauthorised structures and bringing them under the tax ambit. Speaker Sir, the projects as at Annexure - J amounting to Rs. 218.82 crores will be completed in this Financial Year. The projects as at Annexure - K will be taken up in this financial year. For undertaking other works, a provision of Rs. 40 crores has been made for the IDMT scheme in this year.

<u>INDUSTRIES</u>

Speaker Sir, the allocation to the Industries Department is Rs. 74.12 crores.

Speaker Sir, we aim to have holistic development of MSME's in the state under the World Bank funded RAMP programme of the Central Government. I propose to provide Business Facilitation Centers in major cities and Kiosks to help and support the MSME's for all their services, schemes as well as online dispute resolution and provide them necessary assistance in sustainable development through Greening Initiatives, Gender Inclusion, Capacity Building and Training, through the RAMP programme. An SIP of Rs. 262 crores is proposed over 4 years with State contribution of Rs. 42.50 crore.

Speaker Sir, to facilitate and implement Ease of doing business in the State, Goa Investment Promotion and Facilitation Board (Goa-IPB) will be provided with a budgetary support of Rs. 7 crores over the period of 2 years.

Speaker Sir, under the Logistics and Warehousing Policy 2023 formulated with the objective of improving the logistics infrastructure and logistics services in the State of Goa, I propose to implement significant incentives schemes to boost investment in the Logistics and Warehousing sector. The total expected budget is 25 crores per year for the next 2 years.

Speaker Sir, India's first Digital Public Good for industry governance developed by Goa-IDC will be expanded to include all industry-related clearances, aiming to become a single-window portal for industries in this year by June 2024. It is proposed to upgrade the infrastructure in industrial estates totalling to Rs. 80 crores.

Speaker Sir, I propose to auction 20% of the available industrial and commercial plots across industrial estates in this year to generate revenue for infrastructure financing and I also propose to offer incentives to women entrepreneurs, start-ups, and industries that adopt sustainability practices.

Speaker Sir, I propose to allocate plots in Industrial Areas or in the vicinity of Industrial Areas for building of hostels and commercial outlets in association with the industries interested in housing their employees in these hostels. Further, the transport facility in the industrial areas will also be strengthened by providing more buses especially in the night shifts.

HANDICRAFTS, TEXTILE AND COIR

Speaker Sir, the allocation for Handicrafts, Textile and Coir is Rs. 24.27 crores.

Speaker Sir, the handicrafts sector plays a vital role in preserving the cultural heritage and promoting craftsmanship. However, the lack of modern equipment hinders its growth. To address this, my Government proposes a new scheme "Mukhyamantri Hastakala Adhunikaran Yojana" under which the focus will be to enhance productivity, quality and innovation in the handicrafts sector by providing 90% subsidy on the procurement of new equipments and modern machinery. The budgetary provision of Rs. 41 lakhs is made for implementation of this scheme for the financial year 2024-25.

Speaker Sir, I also propose to increase stipend per actual working day to be provided to the skilled handicrafts, textiles and coir artisans who undergo

handholding support program under the scheme, Swavalamban Yojana for Handicrafts Artisans. Budgetary provision of Rs. 1.17 crores is made for providing stipend under the scheme, Swavalamban Yojana for Handicrafts Artisans for the financial year 2024-25.

Speaker Sir, for the upcoming Kunbi Handloom Crafts Village in the Uguem village of Sanguem taluka which is being built with assistance from Central Government, Rs. 3 crores has been earmarked.

MINES

Speaker Sir, my government has successfully auctioned four mining blocks in First Notice Inviting Tender (NIT) and five mining blocks in Second Notice Inviting Tender (NIT) in the State. Total of 9 iron ore mining blocks have been auctioned from 2022 till date.

Speaker Sir, my Government has also notified dump policy for handling and auctioning of various dumps located in different locations in the State of Goa. We will soon commence auctioning of the dump. We are also in the process of starting the sand mining through a proper policy and also extending the duration of the lease period for minor minerals in the State.

Speaker Sir, I propose to renew the "Reimbursement of Green Tax and Fitness fee to the mining affected truck owners scheme" to provide financial assistance to the tipper truck owners who have been adversely affected due to the closure of all mining and related activities in the State of Goa.

INFORMATION TECHNOLOGY

Speaker Sir, the allocation to the Information Technology Department is Rs. 154.95 crores.

Speaker Sir, under Goa Startup Policy new schemes are proposed to make it more inclusive and realise the vision of Goa as a Creative Capital.

A digital nomad friendly enablement will be pursued so that professionals and startups could work out of Goa anytime and at multiple locations.

To give impetus to the startup mission in Goa, my Government has planned to establish a Section 8 company on the lines of best practices followed in the world. The company will provide essential support in terms of investment, manpower training, research,innovation, market access, etc. Further it is proposed to place the Startup and IT Promotion (SITPC) under this company.

I propose to start state of the art co-working spaces on the beaches so as to provide better working facilities with scenic views for the companies.

My Government will start an accelerator program to support start-ups that are working in the social impact space who in turn create massive social and economic impact

My Government is in process of formulating various schemes under the Drone Policy to enable manufacturers, service providers and drone enthusiasts to benefit from the policy.

Speaker Sir, Artificial Intelligence based Chatbot solution will be implemented under which citizens/stakeholders receive relevant data or information instantly without visiting the concerned department. Initially it is planned to develop the chatbot solution for 3 domains i.e. Tourism, Public Grievances & Goa online. Subsequently, on successful completion of these sectors, additional 5 sectors will be onboarded.

The Department is in process of establishing 100+ Wi-Fi hotspots across the state at the identified locations for providing free internet services to the citizens across the state of Goa.

FORESTS

Speaker Sir, the allocation for the Forest Department is 149.92 crores. The projects worth Rs. 14.49 crores will be taken up under upgradation of Bondla zoo and Chodan.

ENVIRONMENT

Speaker Sir, the allocation to the Environment Department is Rs. 20 crores.

Speaker Sir, for the Scheme to Promote the conservation of Environment and Ecology by Educational institutions and Research Institutions through means of conducting workshops and exhibitions and also providing assistance for participation in seminars workshops in India or Abroad, a provision of Rs. 60 lakhs has been made.

Speaker Sir, I propose to carry out Noise Mapping, in order to identify Hot Spot sources and to have mitigation plans for Noise Pollution Control in the State of Goa at an estimated amount of Rs. 2.35 cores.

Speaker Sir, my Government has completed the process for preparation of Coastal Zone Management Plan, 2011 as per CRZ Notification 2011 and the

Ministry of Environment Forest and Climate change has notified the CZMP-2011 in 1:25,000 scale and CZMP-2011 in 1:4,000 scale is under submission.

Speaker Sir, 10 new multiprocessing centres of Goa State Biodiversity Board under the GoVan Project will be made functional in this year.

Speaker Sir, a framework for Green Climate Fund is being developed with assistance from the World Bank to mobilise funds and through intermediaries as partnerships with National Development Financial institutions such as SIDBI and NABARD. The total cost of the project is approximately Rs. 1,650 crores.

Speaker Sir, National Plan for Conservation of Aquatic Ecosystem, Integrated Management Plan for Ramsar Site and Framework Management Plan for Ramsar Site will be taken up with Central Assistance at a cost of Rs. 10 crore.

EMPLOYMENT

Speaker Sir, my Government of Goa has transformed the manual services rendered by Goa Employment Exchange to online portal to create a job matching in a dynamic, efficient and responsive manner between the Goan Job Seekers and Employers creating a virtual handshake between the Employers and the prospective Job seekers.

Speaker Sir, I also propose to make it mandatory for the people employed in the private sector to register in the Employment Exchange for getting Government Jobs, which will also help the Government in counting their experience while providing jobs.

Goa Human Resource Development Corporation

Speaker Sir, GHRDC has been a success story where all the 4,162 manpower engaged for various purposes are diligently discharging their duties in various Government Departments and Autonomous Bodies. Reservation for experienced GHRDC staff in uniform cadre is in final stages of implementation and will be done in this financial year.

FACTORIES AND BOILERS

Speaker Sir, the allocation for Factories and Boilers is Rs. 14.81 crores.

Speaker Sir, As a part of initiative towards Ease of Doing Business, I propose to rationalise and simplify the existing process of approval of plans and

registration & grant of licence for the factories. I also propose to suitably increase existing fees for small factories and for medium and large factories.

As a part of initiative towards monitoring the health of the workers beyond occupational health, I propose to conduct medical / screening camps in factories once in two months to detect diseases such as breast cancer, prostate cancer, etc. amongst workers which are normally not detected during pre-employment and periodic medical examinations. This will be over and above the awareness camps organised in factories on lifestyle disorders, ergonomics and other medical topics.

Specialised training programmes for middle management and senior management level employees will be provided on topics such as Legal Requirements, Safety in Operation and Maintenance Pressure Vessels, etc. in association with NGO's / Institutions dedicated to Occupational Safety, Health, and Environment.

EDUCATION AND SKILL DEVELOPMENT

Speaker Sir, the allocation to this sector is Rs. 3,243.40 crores.

SCHOOL EDUCATION

Speaker Sir, today the world is changing rapidly and our education system needs to be at par to these changes. Sant Tukaram Maharaj has said that,

"अधिकार तैसा करावा उपदेश। साहे ओझें त्यास तें चि द्यावे। मुंगीवरी भार गजाचें पाळण। घालितां ते कोण कार्यसिद्धी।।"

My government is committed to implement a relevant, progressive and enjoyable education system. The country's new education policy envisages an education system that drives the interests, abilities and skills of every student. It is a matter of pride that Goa is leading the country in implementing National Education Policy in this direction.

Speaker Sir, in order to translate the National Education Policy 2020 into complete action, I propose to establish The Goa State School Standards Assessment and Accreditation Authority to assess quality standards of School Educational Institutions. Necessary School Quality Assessment and Accreditation Framework (SQAAF) for this will be notified within six months.

Speaker Sir, the allocation to Education has been increased to Rs.2,288.33 crores, an increase of 4.2%. Due to high demand from schools all over Goa, the number of Counsellors and Supervisors under "Mukhyamantri Samupdeshan Yojana" will be increased to 175. I also propose to provide reservation to EWS category candidates in recruitment done in aided schools.

Speaker Sir, this year I propose re-construction of Government Primary and High Schools at Marcel, Bethodra, Agassim, Van (Bicholim), Volvoi and Mangeshi. Further the ongoing school works are as at Annexure - 2.

Speaker Sir, I am pleased to inform this august house that the District Institute of Training and Education has been selected by the Ministry of Education as "Centre of Excellence" and will be upgraded at a cost of Rs.14.95 crore with Central Assistance.

Speaker Sir, further to improve quality standards of Government Schools, I propose to launch the "Mukhyamantri SUVIDHYA" programme. Under this programme, Government schools from primary to Higher Secondary level will be provided with State of Art Academic facilities along with quality upgradation of teachers and educators. Various MoUs signed by the School Education Department with multiple agencies are at Annexure - 3.

HIGHER EDUCATION

Speaker Sir, the allocation to the Higher Education Department is Rs. 553.77 crores.

Speaker Sir, my Government has provided excellent infrastructure, where some of our Government Colleges are comparable to some of the best colleges in India. To take higher education to the next level, I propose to establish a state-of-the-art Talent Development Centre to provide world-class training to our faculty. This centre will house state-of-the-art Laboratories in Science and Mathematics, where classroom concepts are converted to hands-on experiential based teaching and will be established with the support of Indian Institute of Science.

Speaker Sir, my Government is proud to unveil the implementation of the SAMARTH e-Gov Suite in all Higher Education Institutions across Goa including Technical and Medical Institutions. This comprehensive and integrated e-governance platform is designed to streamline administrative processes, enhance the overall educational experience, and empower both

students and educators with cutting-edge technology, aligned with the National Education Policy (NEP) 2020.

Speaker Sir, we wish to take research to the local communities by introducing a new 'Interdisciplinary Research Interventions Schemes' (IRIS) for local Development which will help further enhance our people's economic status. It will help the local communities manage their resources more effectively and sustainably, thereby helping fasten the progress of communities. Through this scheme, funds for research will be provided to interdisciplinary teams of researchers to work on a chosen village or a local community, and come up with workable recommendations and solutions for the identified local problem.

Speaker Sir, many employed and self-employed people are not able to take up Higher Education because of the lack of opportunities of open schooling. In order to encourage lifelong learning and to give opportunity to every individual to continuously upgrade their educational qualification, I propose to establish a full-fledged regional centre of Indira Gandhi National Open University at Farmagudi, Ponda. Further, details of various MoUs signed by the Higher Education Department with multiple agencies are at Annexure - 4.

TECHNICAL EDUCATION

Speaker Sir, the allocation to Technical Education is Rs. 323.98 crores.

Speaker Sir, in the last budget, I had proposed to implement New Education Policy in all the Technical Institutions in the State. As a step towards this, the premier Goa Engineering College and Goa College of Pharmacy have already been accredited for all its courses, along with two other private Engineering Colleges. Other technical institutions are also being supported to obtain accreditation at the earliest.

Speaker Sir, Diamond Jubilee Government Investment for Technical Education Scheme (DJ- GIFT) which has benefited thousands of students pursuing Technical Education courses, will continue to be implemented in 2024-25, for which budget provision of ₹32 crores has been allocated.

Speaker Sir, my Government has continuously focused on developing a scientific mindset among the students. Various initiatives such as Vigyaan Dhara, Science Film Festivals, Skill Library, Science Vigyan Mahotsav, STEM Lab etc. are a step towards this initiative. Various MoUs signed by the Technical Education Department with multiple agencies are tabled at Annexure - 5.

The Scheme for Coding and Robotics Education in School Scheme has been successfully implemented in over 400 schools across the State. ICT equipment worth Rs.15 crores have been provided to upgrade the labs in the various schools for effective implementation of the Scheme. For the next year, an amount of Rs. 16 crores has been earmarked for this Scheme.

The construction of phase III buildings at Government Polytechnic, Curchorem at an estimated cost of Rs.9.00 crores will be completed in this financial year. I also propose to upgrade the infrastructure of Goa College of Arts which includes new Applied Art classrooms, state of art lecture halls and space for a student's art gallery/exhibit area.

SKILL DEVELOPMENT

Speaker Sir, the allocation to Skill Development is Rs. 107.37 crores.

Speaker Sir, in order to enhance the standards of all ITI's and in order to attract mainstream students, I propose to start specialised and advanced skill-based courses in the ITI's with Industry collaboration as per the need of local Industry. The experts from the industry will be hired for conducting training in these courses.

Speaker Sir, I also propose to launch a Dual Certification Programme wherein skill-based certification will be offered through Dual Certification Training Programme. Under this programme, students from General Streams like Arts, Commerce and Science will be offered skill-based courses. Further, details of various MoUs signed by the Skill Development Department with multiple agencies are at Annexure - 6.

Speaker Sir, I have noticed that there is an urgent need to provide continuous training to ITI instructors to upgrade their own skills. Therefore, I propose to start an Institute of Training of Trainers (IToT) for training Vocational Instructors of all Government ITIs with the help of IIT, Goa, NIT Goa, BITS Goa and Goa Institute of Management and other eminent institutions.

AGRICULTURE

Speaker Sir, the allocation to Agriculture Department is Rs. 259.30 crores.

Speaker Sir, I propose to enhance one time assistance from existing Rs.80,000 per ha to Rs.1 lakhs per ha to the eligible vegetable cultivating groups or individuals on project basis under the scheme "Assistance for

cultivation of vegetables by Self Help Group's/Individuals". The budget provision of Rs. 50.00 lakhs is proposed for the F.Y. 2024-25.

Speaker Sir, I propose to take up Cashew Cluster Development with the financial assistance under National Horticulture Board, Government of India for all the three components of pre-production and production, Post Harvest Management and Value Addition and Logistics, Marketing and Branding of Goa cashew. I also propose to construct a new administrative building for Goa College of Agriculture at Ella, Old-Goa for which provision of Rs. 10 crore has been made.

Speaker Sir, it is observed that, the small & marginal farmers are getting less subsidy under the scheme "Desilting and Revitalization of Ponds and Tanks". To benefit such farmers, it is proposed to enhance the assistance on evaluated cost restriction of Rs.70,000/ per ha of command area of pond to the farmers/Self Help Group's. The budget provision of Rs. 16.80 lakhs is proposed for the F.Y. 2024-25.

Speaker Sir, it is proposed to increase assistance from existing to Rs.5,000/per ha under the scheme "Western Ghat Development Programme". which is implemented in five Talukas namely; Sattari, Dharbandora, Sanguem, Quepem and Canacona, to develop fragile land, support landless farmers by distributing of trees, shrubs and medicinal plants. The budget provision of Rs.22.63 lakhs is proposed for the F.Y. 2024-25.

It is proposed to increase the cost from existing Rs.10,000 per programme to Rs.15,000 per programme to conduct one day training programme for 50 farmers. Similarly, to conduct Krishi Mahotsav for 500 farmers, it is proposed to increase the cost from existing Rs.1.25 lakhs to Rs.1.50 lakhs per programme under the scheme "Western Ghat Development Programme". The budget provision of Rs.9.25 lakhs is proposed for the F.Y. 2024-25.

In order to motivate the farmers to install Micro Irrigation system to increase farmers yield and productivity, it is proposed to enhance the subsidy limit for borewell, open well and Drip / Sprinkler etc. The budget provision of Rs.2.20 crores is proposed for the F.Y. 2024-25.

Speaker Sir, 08 Khazan bund works amounting to Rs. 18.74 crores are scheduled to be completed during the financial year, 2024-25 i.e. 04 in Ponda, 02 in Bicholim, 01 in Tiswadi and 01 in Salcete Taluka. Also, 15 Khazan bund works will be commenced during the F.Y.2024-25 i.e. 05 in Tiswadi, 04 in

Bardez, 02 in Ponda, 02 in Bicholim, 01 in Salcete and 01 in Mormugao Taluka.

Also, the seed processing and Storage Unit at Government Farm, Ela, Old-Goa is expected to be completed by May, 2024. I also propose to set up an Agro Food Park in an industrial estate with assistance from the Central Government.

The first Phase of Centre of Excellence (COE) will be inaugurated during the F.Y. 2024-25. COE is established for high value vegetables & flowers with high-tech intervention on production & post harvest management at Government Agricultural Farms at Kodar, Ponda taluka. The proposed budgetary allocation is Rs.8.63 crores.

The office buildings of Zonal Agriculture office Valpoi and Zonal Agriculture office Ponda will be completed by March 2025.

Launch of e-Agri Marketing Place with online marketing mobile APP for the benefit of small & marginal farmers and the farming community. The proposed budgetary allocation is Rs.70.00 lakhs.

ANIMAL HUSBANDRY AND VETERINARY SERVICES

Speaker Sir, the allocation to the Animal Husbandry Department is Rs. 180 crores.

Speaker Sir, I propose Reconstruction of Pashusamvardhan Bhavan comprising 4 floors with basement parking facility. The Office of the Animal Welfare Board and State Veterinary Council would be set up in this building. It is also proposed to establish a State of the art Laboratory with a Surveillance Cell.

Speaker Sir, I propose to set up a College of Veterinary Science in the State to provide opportunity to the aspiring students within the state of Goa who otherwise have to avail such education from outside the state.

Speaker Sir, I propose to upgrade the existing Disease Investigation Unit to State Laboratory for Disease Surveillance and also to set up District Laboratories at Veterinary Hospital, Mapusa and Veterinary Hospital, Sonsodo, Margao, respectively. It is also proposed to establish mini Labs in Veterinary Hospital, Honda and Veterinary Hospital, Ponda.

Speaker Sir, it is proposed to establish Operation Theatre and rehabilitation for Large animals at Cattle Breeding Farm, Copardem, Sattari.

I propose Setting up a Goatery Farm of 100 Female and 10 Male of two different breeds at the Government Cattle Breeding Farm, Copardem, Sattari - Goa with a proposed Budgetary allocation of Rs. 1.00 Crore.

Speaker Sir, I propose to introduce Muzzle Identification – GODHAAR - Unique ID for Cows. The muzzle pattern is unique like a fingerprint that can be linked with numbers like 'AADHAAR' in the human population. The unique pattern in the muzzle can be captured through a photo from a mobile phone. The technique will be totally non-invasive and prevent the pain and suffering to the animal which normally occurs during ear tagging and microchipping.

Speaker Sir, my Government proposes to avail the services of freshly graduated BVSc. Candidates, sponsored by Government to engage them as interns with stipend of Rs 30,000/- per month for a period of one year as they are bound to serve the state for one year after completion of studies as per the agreement signed with the Government.

Speaker Sir, I propose to simplify the procedure of release of grants to Goshalas under the Stray Cattle Management Scheme under which the grants will be directly released to the Goshala based on the certification by the local Veterinary Officer.

FISHERIES

Speaker Sir, the allocation to the Fisheries Department is Rs. 84.03 crores.

Speaker Sir, I propose to implement Mukhya Mantri Nustekar Bima Yojana wherein the active fishers will be provided Insurance cover who are prone to accidents at sea due to rough weather and other natural calamities. I also propose to provide "Matsya Vaahinis", Eco-friendly movable Fish kiosk to fishermen at an estimated cost of Rs. 4.25 crores.

Speaker Sir, the Construction of State of Art Wholesale Fish Market at Margao is scheduled to be completed in this year at a cost of Rs. 41.25 crores. For upgradation of fisheries infrastructure at various locations across the State, total capital outlay of Rs. 42.12 crores has been provided. We are also in the process of considering reintroducing subsidies on diesel for our fishermen community.

SOCIAL WELFARE

Speaker Sir, the allocation for the Social Welfare Department is Rs. 553.72 crores.

Speaker Sir, it gives immense pride to inform this august House that Students with Disabilities from Goa represented India, where we won 19 medals in various sports at the 2023 Special Olympics World Summer Games – Berlin from Special Olympics Bharat.

Speaker Sir, my Government has introduced the CM Scholarship Portal to ease the process of scholarship disbursement to students belonging to various categories through a single portal. For scholarships of the Social Welfare Department under various schemes, an amount of Rs. 7.16 crores has been allocated.

Speaker Sir, works under the Pradhan Mantri Jan Vikas Karyakram will be undertaken to develop infrastructure projects, which will be community assets in the development deficit identified areas for socio-economic development of the said areas.

Speaker Sir, from this year onwards, the various Corporations of the Government working for welfare of minorities, backward classes and tribal welfare will be strengthened and made more proactive in disseminating benefits of various schemes to the citizens.

Speaker Sir, Government proposes to introduce the "Home Loan Interest Subvention Scheme" wherein the Government will bear part of the interest component of the Pradhan Mantri Awas Yojana loan of the all beneficiaries for which an amount of Rs. 15 crores has been allotted.

Speaker Sir, for the flagship "Dayanand Social Security Scheme", an amount of Rs. 436.80 crores has been earmarked. I also propose to extend support to various agencies engaged in "Nashamukt Bharat" programme of Government of India.

Speaker Sir, the old aged homes under Provedoria will be refurbished and renovated in this financial year. Further, an allocation of Rs. 28.17 crores has been made for the newly created department of empowerment of persons with

disabilities. I also propose to strengthen the PM Divyansh Kendra established in GMC.

WOMEN AND CHILD DEVELOPMENT

Speaker Sir, the allocation to the Women and Child Department is Rs. 406.70 crores.

Speaker Sir, for the first time I will be placing the Gender Budget statement on the floor of this house which aims at consolidation and analysis of overall budgetary resources that the State of Goa allocates and spends on the programmes and schemes that benefit women directly as well as indirectly.

Speaker Sir, for the flagship schemes of the Government i.e Griha Aadhar and Ladli Laxmi, an amount of Rs. 281.20 crores has been earmarked.

TRIBAL WELFARE

Speaker Sir, the allocation to Tribal Welfare Department is Rs. 135.87 crores.

Speaker Sir, the Ministry of Tribal Affairs, New Delhi has approved an amount of Rs. 15.00 Crores towards the project "Tribal Museum of Freedom Fighters of Tribal Communities at Ponda" which will be constructed in Bandora, Ponda.

The Memorandum of Understanding was signed between the Directorate of Tribal Welfare and Disha Foundation for content Development and curation work of Tribal Museum.

The subcommittee of the steering committee under the Chairmanship of Director, TRI identified 54 names of the Tribal Freedom Fighters.

Speaker Sir, the following projects of Tribal Welfare are proposed under Grants to be received as per Article 275(1) of Indian Constitution:

Speaker Sir, my Government has settled 1,457 cases under the Forest Rights Act and I expect to settle 50% of the Forest Rights cases by March 2025.

CO-OPERATION

Speaker Sir, the allocation to Co-operation Department is Rs. 40.23 crores.

Speaker Sir, I propose to extend 54 major initiatives of the Ministry of Cooperation, Govt. of India such as Strengthening of Primary Agricultural Cooperative Societies (PACS) through computerization, World's largest decentralised grain storage program to ensure food security, LPG dealership, common service centres, Jan Aushadhi Kendra for access to generic medicines at rural level etc. for all PACS societies in the State so as to increase the income of PACS and meet new employment opportunities in the sectors like Dairy, Fisheries, Storage etc by getting new possibilities for the economic development and expansion of PACS.

Speaker Sir, various schemes of the department will be improved to bring a large number of unorganised artisan/workmen in the fold of Cooperative societies in their own villages. These include people engaged in traditional occupations like Handloom weavers, Pottery artisans, Bamboo artisans, marginal farmers etc in the remote villages of Goa.

Speaker Sir, I propose to introduce a Deposit protection Scheme to provide relief up to Rs.1.00 lakh to the depositor in the event of society goes into liquidation. It is also

proposed to provide financial assistance for the upgradation of office premises of the Primary Agricultural Cooperative societies.

Speaker Sir, under the Central scheme "Strengthening of Cooperative Through IT Interventions", we propose to undertake development of software for digitization of processes and operations of Registrar of Cooperative societies covering the software modules like Registration of Cooperative, Amendment of Bye Laws, Annual Return Filing, Audit, Election etc. at an estimated cost of Rs. 1.5 Crore.

CIVIL SUPPLIES

Speaker Sir, the allocation to Civil Supplies Department is Rs. 68.69 crores

Speaker Sir, a Common Service Centre is an IT enabled front-end delivery point for Government, private and social sector services for delivering E-services like Payments of Water/Electricity bill, Issuing/ Correction of Birth, Death, Income, Caste Residence Certificate etc. to rural and remote locations where IT facilities are limited. As of now 82 Fair Price Shops have been transformed as Common Service Centers. More such FPS will be made functional as CSC based on the request of FPS owners.

Speaker Sir, I am pleased to announce that as on date, there are no Public Distribution System Kerosene beneficiaries left in the State of Goa and hence we are declaring Goa as Kerosene Free State.

Speaker Sir, I propose to upgrade the existing AePoS devices from the current 2G network to 5G network for enhanced connectivity. To further enhance transparency and accountability in the distribution of foodgrains to Fair Price shops dealers and beneficiaries, we have decided to carry out Integration of Weighing Scales in all taluka godowns and weighing Machines of all Fair Price Shops dealers with the software and AePoS devices.

Speaker Sir, under the "Chief Minister Financial Assistance for refilling of LPG Cylinder Scheme", the Antyodaya Anna Yojana beneficiaries are provided compensation towards the cost of 3 refills of LPG Cylinder per annum. The beneficiaries under this Scheme are being paid an amount of Rs. 275/- per month, towards assistance for purchase of LPG Cylinder directly to the Bank Account of the head of the family. For this scheme, Rs.3.69 crores has been allocated for the year 2024-25.

REVENUE

Speaker Sir, to improve the living standards of the Scheduled Tribes and Economically Weaker Sections of the society, especially their housing needs, I propose to formulate a scheme "Bhagwan Birsa Munda Bhudaan Yojana" for allotment of a plot of 100 sq. mts. with increased FAR to the Schedule Tribes and Economically Weaker Section of the society, throughout the state of Goa in Constituencies in which more than 20% of the population belongs to the ST community.

Speaker Sir, my Government is in process to implement a single window system for issuing NOC/permission for amplified sound, beach weddings, and events, etc.

Speaker Sir, Goa being a touristic State, a lot of outdoor events both of National and International repute are being held and there is lot of demand for holding such events. Inorder to promote such events, there is a huge requirement of land. As such, my Government intends to procure land in both the Districts, so as to facilitate in organising such events, exhibitions etc.

Speaker Sir, I propose to undertake rehabilitation of the people displaced at Mapusa Tarikade to Colvale at an estimated cost of Rs. 3.45 crores through Goa rehabiliation Board. I also propose to construct a Market Complex at Old Goa through the Goa Rehabilitation Board.

COLLECTORATES

Speaker Sir, the allocation to Collectorates of both Districts is Rs. 107.61 crores.

Speaker Sir, I am pleased to inform this house that for the first time my Government has taken initiatives for speedy disposal of Mundkarial Cases. Deputy Collectors, Mamlatdars and Joint Mamlatdars are taking hearings of Mundkar Cases on Saturdays, which has shown substantial impact on disposal rate. It is proposed to extend the same to Tenancy Cases also.

Speaker Sir, for speedy response to inconsistent conditions and any disaster in South Goa District, it is proposed to set up a fully equipped and dedicated command and control set up in both the Collectorates.

Speaker Sir, procedure simplification will be carried out in respect of disposal of applications under Goa Regularization of Unauthorized Construction Act 2016, so as to dispose of all the cases by March 2025.

Speaker Sir, I propose to bring Quality Management in the Collectorate system of Goa. Accordingly, both the Collectorates will standardise their processes and opt for ISO Certification in 2024-25.

LAND RECORDS

Speaker Sir, the allocation to the Department of Settlement and Land Records is Rs. 40.77 crores.

Speaker Sir, in order to alleviate the problems of Sanguem residents and provide various land survey services, I propose to establish new office of Settlement of Land Record in the Taluka of Sanguem. Additional ISLR's will also be provided in Bardez, Tiswadi and Dharbandora taluka for faster service delivery.

Speaker Sir, it is proposed to prepare "One Goa One Map" having various features existing on land parcel. Scanning and cataloguing of all legacy records which are in Portuguese language will be done and the same will be placed in public domain.

TOWN AND COUNTRY PLANNING

Speaker Sir, the allocation to TCP Department is Rs. 37.78 crores. I propose that the Building Plan Approval Management System will be extended to all types of buildings. Also, the recommendation of Conversion application under Land Revenue code will be provided through Online Mode. The Goa Land Development & Building Construction Regulation, 2010 will be further amended to facilitate development of land even in remote villages by formulating policies for Economically Backward Areas.

SCIENCE AND TECHNOLOGY

Speaker Sir, the allocation to the Science and Technology department is Rs. 209.62 crores.

Speaker Sir, dumping of waste in rural areas collected from commercial establishments is a cause of concern. To tackle this issue, I propose to undertake collection and transportation of waste by Goa Waste Management Corporation from commercial establishments like hotels and other commercial entities on a fee that shall be arrived at based on certain criteria.

Speaker Sir, it has been observed that garbage management funds going to various local bodies such as Village Panchayats as well as Municipal Councils

are lying unutilised. The waste of these local bodies is treated by GWMC. Hence, I propose to transfer the proportional quantum of these waste management to Goa Waste Management Corporation, henceforth.

HOME DEPARTMENT

Speaker Sir, the allocation to Home Department is Rs. 1226.10 crores.

Speaker Sir, as per the Goa (Abolition of Proprietorship, Titles and Grants of Lands) Act, 2014, all rights, titles and interests of Custodian of Evacuee Property stands transferred to the District Collector (North). My Government intends to locate all the Evacuee Properties within the State and obtain possession of the said properties to the Government and also dispose of the said properties as per the provisions in the said Act.

Speaker Sir, I also propose modernization of all departments under the administrative control of the Home Department.

POLICE

Speaker Sir, the allocation to the Police Department is Rs. 948.83 crores.

Speaker Sir, to ease the life of citizens, an initiative of filing FIR online (e-FIR) is at an advanced stage and will be launched shortly. I also propose to strengthen the cyber cell of Police Department.

Speaker Sir, Construction of new buildings for Maina Curtorim Police Station, Sanguem Police Station, Fatorda Police Station, Construction of new Police Headquarter building and Construction of Coastal Security Police Station at Talpona will be commenced during 2024-25 for which total capital outlay of Rs. 32.99 crores has been provided.

Speaker Sir, I also propose to undertake Construction of 30 'B' type Quarters at Arlem Fatorda, Construction of 24 'B' & 24 'C' type Police Quarters at Altinho, Panaji and Construction of 08 'B' and 10 'C' type Quarters at Maina Curtorim with Central Assistance of Rs. 50 crores.

HOME GUARDS AND CIVIL DEFENCE

Speaker Sir, the allocation to Home Guards and Civil Defense is Rs. 44.92 Crore. In order to reduce the large number of road accidents in the State, the Home Guards would be enlisted as Road Safety warriors and deployed at various crucial points across the State. Goa is the first state in the country

wherein Home Guards who have completed 15 years of service have been given regular jobs in the Police Department.

FIRE AND EMERGENCY SERVICES

Speaker Sir, the allocation to Fire and Emergency Services is Rs.130.98 Crore. inorder to strengthen our disaster response force, the new fire stations at Bicholim, Valpoi and Vasco will be completed in this year at a total cost of Rs. 26.48 crores. The department will also be equipped with latest fire-fighting equipment worth Rs. 28 crores to effectively tackle the fire hazards. I also propose to establish new Fire Stations in Pernem and Canacona taluka.

JAILS

Speaker Sir, in order to make our Jail self-sufficient using renewable energy sources, I propose to install Solar Panels on rooftops of all the structures in Central Jail Colvale through Goa Energy Development Agency at a cost of approximately Rs. 1 crore.

SAINIK WELFARE

Speaker Sir, I propose to enhance the Cash Grant and Annuity to Gallantry award winner (Chakra Series). The work of construction of Sainik aramgrah (rest house) is likely to be completed by April 2024 at a cost of Rs. 9 crore.

VIGILANCE

Speaker Sir, the allocation to the Vigilance Department is Rs. 11 crores. I propose to undertake computerization of the Directorate of Vigilance which will have integrated complaints monitoring mechanism and online monitoring of submission of statements. I also propose to set up Vigilance Committees for group of Government Departments/Organizations by involving the politically neutral, public spirited, qualified members of the civic society to ensure smooth delivery of Citizen Centric Services, ensure proper utilisation of the Public funds, and report about the deficiencies in the quality execution of public work undertaken by the various agencies.

INFORMATION AND PUBLICITY

Speaker Sir, the allocation to the Information and Publicity Department is Rs. 77.87 crores.

Speaker Sir, my Government is in process of implementing the Goa Journalist Protection Act for the protection of Journalists who are working to strengthen

the fourth pillar of democracy. The Bill has been forwarded to the President of India for his assent.

Speaker Sir, in order to encourage quality journalism and keep a record of the best articles of a publication house for a year, I propose to introduce "Bharatkar Hegde Desai Lekh Sangraha" scheme, under which every publication will be given assistance for publishing books on the best articles published by them in a year. This will be a ready reckoner for the general public as well as researchers in diving deep into their topics of interest.

Speaker Sir, in order to provide conferencing facilities to all the local bodies, I propose to provide two way interactive video conferencing facilities to all local bodies.

Archives, Archaeology, Museum and Goa Gazetteer

Speaker Sir, the total allocation for this Sector is Rs. 77.90 crores.

GOA GAZETTEER

Speaker Sir, Gazetteer of Union Territory Goa, Daman and Diu was published in the year 1979 and the same was reprinted in 2009 without any updates. I propose to publish the second edition of Goa Gazetteer with the latest updates up to 2023 in this year.

MUSEUMS

Speaker Sir, the allocation to Museums Department is Rs. 15.07 crores.

Speaker Sir, from this Financial Year, two schemes "Incentive to Educational Institutions" and "Financial Assistance to Museums" will be revived which are aimed in creating interest about ancient arts and artefacts among the public.

Speaker Sir, in order to keep record of private museums and private collections, I propose to start an official inventory of private museums, private antiquities and private collections of rare, antique and specialised articles.

ARCHIVES

Speaker Sir, the allocation to the Archives Department is Rs. 21.51 crores.

Sir, there are many archival records related to Goa in private collections as well as in the position of various institutions India and abroad. My Government

through the Department of Archives will take an initiative to obtain digital copies to enrich our collection of archival records.

ARCHAEOLOGY

Speaker Sir, the allocation to the Archaeology Department is Rs. 40 crores.

Speaker Sir, the 2 projects viz. Restoration of Fort of Sankhali at the cost of Rs. 3.6 crore and Restoration of Khorjuve Fort at the cost of Rs. 3 crore will be completed in Financial Year 2024-25.

Speaker Sir, as homage to Chhatrapati Shri Shivaji Maharaj who in the year 1667 fought against the Portuguese at Colvale Fort, the phase wise Restoration of Colvale Fort shall be taken up from this Financial year. The estimated cost of Phase - I restoration is Rs. 4 crore.

Speaker Sir, Heritage policy for the State of Goa will be formulated this year, which will enable us to have a proper guideline and framework for Heritage Structures in Goa.

Speaker Sir, as proposed by the expert committee which had been constituted for restoration of temples destroyed during the Portuguese Era, construction of Smruti Mandir will be taken up at a cost of Rs. 20 crores.

Speaker Sir, in addition to above the following works as at Annexure - L will be undertaken in FY 2024-25.

Speaker Sir, it is proposed to notify more number of Archaeological Monuments /sites such as Betul Fort, Nanus Fort, Rock Engravings at Mauxi, Stone circle at Cotigao, Kranti Veer Dipaji Rane's House at Kumbharkhand, Sattari, Soliye temple at Canocana, Tank of Shri. Vazreshwar Temple at Balli and Hath Katro Khamb at Old Goa.

Speaker Sir, in order to encourage research in archaeological field related to Goa, I propose to launch archaeological research fellowship scheme at junior as well as senior level which will cover research in area of Geo-archaeology, Palaeontology, Archaeo- botany, Iconography, Epigraphy, Paleography, etc.

For the Exposition of relics of Saint Francis Xavier in 2024, an amount of Rs.10 crores has been earmarked.

ART AND CULTURE

Speaker Sir, the allocation to Art and Culture Department has been increased to Rs. 201.25 crores.

Speaker Sir, I propose to award the "Mukhyamantri Kala Vriddhi Samman" awards to felicitate 10 artists per year in the age group of 40 to 60 years who have immensely contributed in the field of Art & Culture.

Speaker Sir, I propose to commence work of Ravindra Bhavan Mapusa and other places also in this year upon identification of suitable land.

OFFICIAL LANGUAGE

The allocation to the Official Language department is Rs. 21.70 crores.

Speaker Sir, three new schemes will be launched in this year namely "Promotion and Development of Official Language", "Shanshodhan Ani Shabdavalee Nirmitee Yevzonn" and "Animation and Documentation in Konkani language" for which a total provision of Rs. 85 lakhs has been made. For supporting various institutions which are responsible for preserving the languages prevalent in Goa, a provision of Rs. 6.69 crores has been earmarked. The Centenary Celebrations of Birth Anniversary of Shri. Manoharrai Sardesai and Shri. Ravindra Kelekar will be carried out at a grand level by the State Government.

TOURISM

Speaker Sir, the allocation to the tourism department is Rs. 255.20 crores.

Speaker Sir, my Government has executed an "Master Services Agreement" for installation of the digital advertising screens/panels in order to display social messages, promote unexplored locations/hinterlands, Goan culture and heritage, commercial advertisements as well as to collect tourist statistics on a real-time basis and submit periodical analytics of the same.

Speaker Sir, my Government has implemented the "Homestay and Bed & Breakfast Policy" and "Caravan Tourism Policy" to promote various tourist hotspots and hinterland tourism.

Speaker Sir, under the Village Development Scheme, my Government will assist various villages based on their potential such as demographics, natural attractions, potential for tourism development, etc. for which a budgetary provision of Rs. 50.00 lakhs has been made.

Beach Shacks/Deck beds in Government property:

The New Tourism Shack Policy for Tourist Seasons 2023-26 (3 Years) is formulated as per the suggestions and recommendations made by the various Departments and Shack Associations. The draft policy for placement of deck beds, umbrellas, tables, chairs, sofas and registration of temporary shacks, hotels, and temporary huts / cottages in private properties, on public beaches for the new tourist season has been prepared and will be notified shortly.

Introduction of Experiential Tours and Hinterland tours

Speaker Sir, my Government has introduced various experiential tours such as Raj Bhavan Tours and tours to Mayem and Canacona for the purposes of providing offbeat tourism offerings to the tourists, which helps in exploring hinterlands of the state. In addition to the same, we are also planning to launch hinterland tours in various parts of the State to places covering hinterland areas of the State.

Speaker Sir, my Government has partnered with three experienced agencies for providing nature trails, architecture tours, heritage trails, village walks, spiritual trails, nature/bird watching, camping, bike tours, food and culinary tours, and brewery tours. This will help the tourists explore various new aspects about the Goan culture and diversity.

Direct flight connectivity from Goa to Dehradun, Uttarakhand.

Speaker Sir, my Government has signed a MoU to express the mutual interest in exploring and developing a joint plan for bilateral cooperation in Travel & Tourism by facilitating a direct flight connectivity, cultural exchange, promotion of joint packages and human resource development based on mutual interests between Uttarakhand and Goa.

Speaker Sir, my Government has signed a MoU with a professional agency towards Empowering the Temple Tourism & promotion of Temples of Goa with the Temple Connect Digital and Social Network.

Promotion of Dudhsagar Trails:

GTDC, in association with the Forest Department, aims to provide well-organised trekking services to visiting guests. GTDC has already selected a service provider for Conducting Monsoon Treks/Trails and regulating Jeep Safari at Dudhsagar Waterfall, Goa, the service provider will be introducing an online ticketing system, which shall provide options for online booking for the treks and tours.

Speaker Sir, in order to complete and upgrade various tourism infrastructure projects in the State, a provision of Rs. 83.10 crores has been provided to GTDC.

PUBLIC PRIVATE PARTNERSHIP

Speaker Sir, the RFP for the Development of the International Convention Centre at Dona Paula on PPP basis will be refloated this year. As a new initiative in public works I propose to take up re-development of Circuit House at Altinho, Government Garage Complex and Junta House in Panaji on PPP basis wherein the entire re-development of these buildings will be taken up at

no cost to Government and revenue share model will be worked out between the Government and the Developer.

Speaker Sir, the PPP Policy for the state of Goa will be finalised this year which will handhold other Departments in monetization of their unutilized or underutilised buildings / assets and also in development of their commercially viable Projects on PPP basis.

LAW AND JUDICIARY

Speaker Sir, the budget allocation to the Law and Judiciary Department has been increased to Rs. 271.48 crores.

The construction of New District and Sessions Courts & Subordinate Courts Complex at Merces in Tiswadi Taluka is scheduled to be completed by May 2024 at a cost of Rs. 178 crores.

Speaker Sir, I propose to implement E-prosecution software to provide electronic communication between Police department and Prosecution department for legal opinion on various types of cases and scrutiny against draft charge sheet.

Speaker Sir, the ongoing work of Civil and Criminal Court at Margao is expected to be completed by December, 2024 at a cost of Rs. 30 crores.

NOTARY SERVICES

The allocation to the Registration Department is Rs. 24.44 crores.

Speaker Sir, I also propose to implement a dynamic allotment mechanism for allocation of registrations of deeds to various sub-registrars across the State. This will reduce the waiting time for the general public and also optimise the distribution of workload among the sub-registrars.

In order to allow the public digital records from anywhere and at any time, we are undertaking Digitization of Notarial records at various sub offices of the Registration Department. This will avoid long queues at the office of Sub Registrars for searching the documents.

CIVIL AVIATION

Speaker Sir, in order to upgrade the Aviation Skill Development Centre at Mopa for providing latest state of the art aviation courses to the Goan Youth, a provision of Rs. 10 lakhs has been made.

PUBLIC GRIEVANCE

Speaker Sir, my Government is in process to create a new Android and IOS App to facilitate the general Public to register their grievances/ complaints. I also propose to set up a new portal for the Goa Time Bound Delivery of Public Services Act where the general public will be able to register their grievances pertaining to the services that are not delivered in time bound manner.

PRINTING AND STATIONERY

Speaker Sir, I propose to modernise the Printing Press by purchasing the latest printing technology machines for which the budgetary allocation to be proposed to Rs. 1.50 crores has been made. Also, in order to reduce the usage of paper, Goa eGazette Software will be launched during this year. I also propose to relocate the Department of Printing and Stationery to new premises.

LEGAL METROLOGY

Speaker Sir, this Department has registered Consumer Welfare Clubs from Schools, Higher Secondary and Colleges in the State and will carry out Consumer Awareness Activities for these Clubs. Consumer awareness will also be conducted by way of Banners, Posters, Street Plays, Video Clips etc. under "Jago Grahak Jago".

Speaker Sir, One new legal metrology Office building with sophisticated Working Standard Laboratory will be set up at Curchorem-Goa for which a total capital provision of Rs. 1.20 crores has been made.

LOTTERIES

Speaker Sir, we have signed an agreement with the marketing agents to market 3 sets of Online Lotteries with Minimum Guaranteed Revenue of Rs. 15 Crores. During the year 2024-25, these 3 Online Lotteries will be made functional. Government will also get a share of 0.30% on the amount of Gross Lottery sales value crossing Rs. 300 crores per annum.

EXCISE

Speaker Sir, I propose to upgrade the Goa Excise Management System software and ease the procedure of renewals, new licences and various other permissions from Excise Department.

PART - B

Speaker Sir, I now move towards tax proposals for the year 2024-25. I would like to bring to the notice of all my fellow Goans that the welfare measures, debt repayment and developmental activities require revenue augmentation. In the last two years, my Government has not drastically revised taxes, rates or charges for the common citizens. The focus has been on the strict enforcement measures and plugging revenue leakages, due to which there is an increase in revenue receipts to the Government.

Speaker Sir, in this year too, I do not propose any increase in taxes for the common citizens. However, there are certain fees and charges which many departments collect which are still less than Rs. 20. All such fees and charges will now be at a minimum of Rs. 20 and there will be an annual nominal revisional clause in such fees due to which there will be periodical revision of these fees.

Speaker Sir, I propose to come up with common guidelines for leave and licence agreements across the State of Goa as there are many agreements which are null and void causing revenue loss to the Government.

Speaker Sir, I propose to rationalise various charges and fees such as Land Revenue fees, Conversion fees and various charges collected by TCP Department for various commercial operations without burdening the common man.

Speaker Sir, I also propose to introduce a one-time amnesty scheme for all the land owners having houses in touristic areas for getting their use of land converted from residential purpose to commercial purpose where the houses have now been converted to hotels/homestays/ restaurants. A certain fixed amount based on the land value will be charged under this scheme which will greatly benefit the common citizens of my State.

Due to the concentrated efforts of the State Government, I am pleased to inform this august house that Goa has achieved 100% saturation in Central Government Schemes such as Jal Jeevan Mission, Bharat Net, Soil Health Card

& Swamitva. On the other hand more than 95% scheme saturation is achieved in case of Pradhan Mantri Awas Yojana (Urban), Kisan Credit Card Agriculture and PM Kisan Samman Nidhi Yojana. In addition to above, 99.9 % scheme saturation is being attained in all the State Government beneficiary oriented schemes. We are a 100% vaccinated State, achieved 100% Financial Inclusion, 100% Direct Benefit Transfer among many other achievements. We are on our way to achieve 100% literacy and Ease of Living on mission mode.

Speaker Sir, as the Chief Minister of the State of Goa, I express my commitment to attain a Golden, Swayampurna and developed Goa that complements and is coherent with the concept of 'Viksit Bharat 2047', which will determine the future course of the country.

I conclude this Budget Address by presenting a Budget that sets the direction towards creating an educated, empowered and developed society by giving full justice for the Nari Shakti, Yuva Shakti, Kisan Shakti and Garib Kalyan. I extend my gratitude to the Members of the Assembly and the entire people of Goa for their cooperation.

Speaker Sir, now I lay the Medium Term Fiscal Plan and Gender Budget Statement before this august house.
